SUBJECT:	CONTRACTOR REQUEST FOR RATE INCREASE - STREET SWEEPING SERVICES

- **Needs:** For the City Council to consider a request from California Street Maintenance for an increase to the current contract amount for street sweeping services.
- **Facts:** 1. On October 20, 1998, the City received a request from California Street Maintenance, the contractor for street sweeping operations, to increase the current contract price from \$7,380.00 per month to \$7,571.88 per month. An increase of \$191.88 per month or \$2,302.56 per year. (See attached letter.)
 - 2. The current contract was for an initial term of two (2) years (which expired on April 30, 1998) with an option to renew for an additional three (3) years.
 - 3. The option period was exercised and the contract was extended on April 7, 1998, upon the adoption of Resolution No. 98-57, which states that the City Council authorized a three year extension "<u>only on the same terms,</u> <u>conditions, and prices as stated in the April 1, 1996, contract and that these shall remain the same during the term of this three year extension."</u>
 - 4. The contract does not provide a mechanism for rate increases, stating only that "*The contractor may not charge more than the amount shown in* <u>Exhibit "B" without prior written approval of the City's Contract Manager</u>.
 - 5. The current adopted budged for street sweeping services was predicated upon the \$7,380.00 per month contract price and an additional appropriation will need to be made if an increase is granted.

Analysis and

Conclusion: In April of 1996, the City entered into a contract for street sweeping services with California Street Maintenance. This contract was for an initial term of two (2) years with an option to renew for three (3) years. The contract price was set for \$7,380.00 per month. Providing a significant savings to the City over providing its own sweeping services.

The option was exercised on April 7, 1998, by the City Council with the adoption of Resolution No. 98-57. Section 1 of this resolution states that the contract would be renewed for an additional three (3) years ...<u>only on the same terms</u>, conditions, and prices as stated in the April 1, 1996, contract and that these shall remain the same during the term of this three year extension."

The contract does not provide a mechanism for increases to the agreed upon price. Section 3 does state that the contractor cannot charge more than the contract price unless written approval is given by the City's contract manager.

The following tables show estimated costs and savings to date for street sweeping operations.

Per our contract we are requesting an increase adjustment to the contract rate due to increases in the following operating costs since April, 1996:

Labor costs Debris costs Insurance costs Sweeper repair costs Fuel costs

Since San Louis Obispo does not belong to any CPI census, we used the Los Angeles area CPI for the period April ,1996, to July, 1998, of 2.8%. For the San Francisco area the increase for the same period is 7.6%; the U.S. city average for the same period is 4.4%. The increase of 2.8% (\$191.88 per month) we feel is extremely modest and fair due to increases in our operating costs.

Hopefully this will meet the Council's approval for our increase.
