- SUBJECT: ADOPTION OF THE 1997 EDITIONS OF THE UNIFORM CODES, AND SUPPORT CODES
- DATE: FEBRUARY 2, 1999
- Needs: To adopt the 1997 Editions of the Uniform Codes, and their support codes in accordance with State mandates.

Facts:

- 1. The Uniform Codes pertaining to construction are updated on a three (3) year cycle.
- 2. The State of California sets the time for adoption of the Uniform (Model) Codes.
- 3. Currently, the City is using the 1994 Editions of the Uniform Codes. Adoption of the 1997 Editions will make the City consistent with the codes adopted by the State of California.

Analysis and Conclusion:

on: The State of California adopted the1997 Editions of the Uniform Codes effective June of 1998. The City has 180 days from the State adoption to adopt the codes by reference. Should the codes not be adopted, they will become effective by State Mandate without the local amendments that meet the specific needs of the City of Paso Robles.

In adopting the Uniform Codes, City Council will be codifying, under the Municipal Code, which codes apply to construction within the City of Paso Robles. The new codes include, International Conference of Building Officials (ICBO) recommended adjustment to building permit fees of approximately ten percent. The fee adjustment reflects changes to the Consumer Price Index between 1993 and 1997. The adoption of the fee schedule is not included in the State Mandate.

Historically, the City has adopted revisions of the fee schedules contained in the codes, consistent with the adoptive cycle. This is consistent with other local jurisdictions (San Luis Obispo, Morro Bay, County of San Luis Obispo), with the exception of Atascadero who collects fees based on a flat percentage of the value of the construction.

AN ORDINANCE OF THE CITY OF EL PASO DE ROBLES AMENDING CHAPTER 17.04 OF THE MUNICIPAL CODE THEREBY ADOPTING THE 1997 EDITIONS OF THE UNIFORM CODES, 1996 NATIONAL ELECTRICAL CODE, AND SPECIFIED SUPPORT CODES.

WHEREAS, the State of California, Division of Building Standards adopts the model codes pertaining to the construction, alteration, and maintenance of buildings on a three year cycle; and

WHEREAS, the State did adopt the 1997 Editions of the Uniform Codes in July of 1998; and

WHEREAS, the California State Health and Safety Code mandates the application of those codes within 180 days of adoption by the State.

NOW THEREFORE, the City Council of the City of El Paso de Robles does ordain as follows:

Section 1. <u>Publication</u>. The City Clerk shall cause this ordinance to be published once within fifteen (15) $\overline{\text{days}}$ after its passage in a newspaper of general circulation, printed, published and circulated in the City in accordance with Section 36933 of the Government Code.

Section 2. <u>Effective Date</u>. This ordinance shall go into effect and be in full force and effect at 12:01 a.m. in the 31stⁿ day after its passage.

Section 3. <u>Inconsistency</u>. To the extent that the terms or provisions of this Ordinance may be inconsistent or in conflict with the terms or conditions of any prior City ordinance(s), motion, resolution, rule, or regulation governing the same subject matter thereof, such inconsistent and conflicting provisions or prior ordinance, motions, resolutions, rules, and regulations are hereby repealed.

Section 4. <u>Section 17.04.010</u> of the Municipal Code, Technical building codes adopted - Copies on file.

The eighteen (18) documents and their respective appendices, as outlined herein, one (1) copy of each of which are on file in the Office of the City Clerk in the City of El Paso de Robles, being marked and designated as the:
