Needs:

For the City Council to conduct a noticed public hearing and make a recommendation to the County Board of Supervisors regarding those activities to be approved for funding with the County's 1999 allotments of Federal Home Investment Partnership Act (HOME) and Emergency Shelter Grant (ESG) funds.

Facts:

- 1. HOME and ESG funds are federal funds allocated annually by the Department of Housing and Urban Development (HUD) to states, "urban counties" and entitled cities. Via a cooperative agreement, the City of Paso Robles is a member of an "urban county" along with the cities of San Luis Obispo, Atascadero, and Grover Beach and the County of San Luis Obispo
- 2. Federal Regulations governing the CDBG, HOME and ESG Programs require that housing and community development needs to which these funds are applied be addressed in a Consolidated Plan. In 1995, the Board of Supervisors adopted a Consolidated Plan for the urban county, taking into consideration recommendations from the participating cities. One Chapter of this plan is the "One Year Action Plan", which is adopted annually.
- 3. The cooperative agreement among the County and participating cities stipulates that CDBG funds will be allocated to each jurisdiction per a HUD-developed formula. The cooperative agreement does not provide for a similar allocation for HOME and ESG funds. The agreement does, however, provide that the County and participating cities cooperate in the allocation of those funds.
- 4. County Planning Staff have requested that the participating cities make recommendations to the Board of Supervisors regarding the proposed allocations of HOME and ESG funds.

- 5. Only one application for 1999 HOME funds is located within the City of Paso Robles. Cabrillo Economic Development Corp. has requested \$300,000 in HOME funds to assist in the acquisition and development of a 61 unit low income senior apartment project at the northwest corner of Creston and Rolling Hills Roads.
- Attached is a "Discussion of the 1999 HOME and ESG Programs" that contains
 background facts about the HOME and ESG Programs and lists those applications
 contained within the Draft One Year Action Plan as being recommended for
 funding in 1999.
- 7. A copy of the Draft One Year Action Plan (4 pages of tables), as prepared by the County Planning Department, is attached.
- 8. A public hearing on the Draft One-Year Action Plan has been set for the Council's meeting of March 16, 1999. Notices of the public hearing were published in the *Telegram-Tribune*. Copies of this staff report were mailed to Cabrillo Economic Development Corp.

Analysis and Conclusion:

To date, the City has not actively sought HOME funds. City staff has, however, informed developers of low income housing aware that they may apply for such funds. CEDC's application for \$300,000 in 1999 HOME funds is not listed in the Draft One Year Action Plan as being recommended for funding because of the uncertainty whether their pending applications for a general plan amendment and a rezone will be approved.

As noted in the attached Discussion, the City has directly and indirectly benefited from HOME funds allocated to the County's First-Time Homebuyers Assistance Program.

The City does not at this time have any homeless or women's shelters that would be eligible for ESG funds. In the past, the City has supported operation of such facilities in Atascadero and in San Luis Obispo.

Attached is a resolution expressing support for the activities as recommended in the Draft One Year Action Plan for funding with 1999 HOME and ESG funds.

RESOLUTION NO. 99-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES RECOMMENDING ACTIVITIES TO BE FUNDED WITH 1999 HOME INVESTMENT PARTNERSHIP (HOME) FUNDS AND WITH EMERGENCY SHELTER GRANT FUNDS

WHEREAS, on July 9, 1996 the City of El Paso de Robles (City) executed a Cooperation Agreement with the County of San Luis Obispo (County) to form an "Urban County" for purposes of allocating annual entitlements to the Community Development Block Grant (CDBG), Home Investment Partnership (HOME) and Emergency Shelter Grant (ESG) grant programs administered by the Federal Department of Housing and Urban Development (HUD); and

WHEREAS, via the Cooperation Agreement, the City agree to cooperate in the allocation of HOME and ESG funds; and

WHEREAS, the 1995 Consolidated Plan adopted by the Board of Supervisors of San Luis Obispo County on May 9, 1995 included Part IV - One -Year Action Plan, which must be updated annually to indicate which projects and programs will receive CDBG, HOME and ESG funding each year; and

WHEREAS, the Urban County expects to receive about \$1 million in HOME funds and about \$91,000 in ESG funds 1999; and

WHEREAS, on December 2, 1998, the urban county conducted a public hearing in Paso Robles for residents of the City and of northern San Luis Obispo County to ascertain the housing and community development needs to be addressed in the One Year Action Plan; and

WHEREAS, in December 1998, the urban county published a "Request for Proposals" for projects to be funded under the 1999 HOME and ESG Programs, which provided that proposals were to be submitted by January 22, 1999; and

WHEREAS, only one application for directly using HOME funds within City limits was filed by Cabrillo Economic Development Corp. (CEDC) for \$300,000 to assist in the development of 61 low income senior apartments; and

WHEREAS, the property on which CEDC proposes to develop the 61 units has not yet been designated for such use by the Land Use Element of the General Plan or by the Zoning Code; and

WHEREAS, no applications were filed for using ESG funds within City limits; and

WHEREAS, on February 12, 1999, the City published a notice in the *Telegram-Tribune*, indicating that a public hearing would be conducted on the Draft One Year Action Plan on March 16, 1999; and

WHEREAS, on February 18, 1999, the urban county released a Public Review Draft One Year Action Plan, which indicated those projects to be proposed to receive HOME and ESG funds in 1999; and

WHEREAS, at its meeting of March 16, 1999, the City Council conducted a public hearing to obtain public testimony on the proposed Draft One Year Action Plan;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of El Paso de Robles, California, to recommend that the Board of Supervisors for the County of San Luis Obispo adopt the 1999 One Year Action Plan, a copy of which shall be kept on file in the Community Development Department, to include the following activities to be funded with the 1999 HOME and ESG funds:

DISCUSSION OF 1999 HOME & ESG PROGRAMS

FACTS ABOUT HOME FUNDS

- 1. HOME funds are federal funds that may be used to provide incentives to develop and support affordable rental housing and homeownership affordability for low income households (those earning 80% or less of the County median income).
- 2. Eligible uses of HOME funds include: site acquisition, construction costs* for new homes and apartments, on- and off-site improvements for housing, rehabilitation costs, financing costs, and first-time homeowner assistance.
 - * Note: CDBG funds may be used for all of the above, except for construction costs for new housing.
- 3. Federal regulations governing the HOME program requires that recipients provide a 25% match. Redevelopment Low and Moderate Income Housing (LMIH) funds may be used as a match. The value of "sweat equity" and welfare property tax exemptions may also be used as a match.
- 4. In the City of Paso Robles, HOME funds were used by Peoples' Self-Help Housing Corp. (PSHHC) to assist in the acquisition of the land for the 71 lot Spring Meadows subdivision east of Airport Road. The County has used a portion of the urban county's annual allotments of HOME funds for first-time homebuyers deferred payment loans, some of which have purchased homes in the City. Indirectly, the City benefited from HOME funds used by the County for consultant services to prepare loan documents prepared for the County's HOME-funded First-Time Homebuyers Loan Program. The City basically used the County's loan documents in the City's CDBG-funded First-Time Homebuyers Loan Program.
- 5. In 1998, PSHHC applied for \$150,000 in HOME funds to supplement \$250,000 in CDBG funds they requested of the City of Paso Robles for an Affordable Rental Housing Development Program. In that program, PSHHC planned to either build new apartments or purchase and rehabilitate existing apartments and restrict their occupancy to low income households. The City did not support that program and the HOME funds were reallocated to purchase of existing apartments in Atascadero.
- 6. Cabrillo Economic Development Corp. (CEDC) has applied for \$300,000 in 1999 HOME funds to assist in the acquisition and development of 5 acres at the northeast corner of Creston and Rolling Hills Roads for 61 low income senior apartments. CEDC has applied applications for a general plan amendment and rezone. These applications were reviewed by the Planning Commission in November 1998. However, CEDC requested that Council consideration be tabled to allow CEDC to refine their project and meet with neighbors. Copies of CEDC's HOME applications have been placed in binders in the City Council Office and at the Counter at City Hall.
- 7. Since 1994, the urban county, of which the City is a member, has received about \$1 million in HOME funds annually. HOME funds are not allocated to member jurisdiction in the same manner that CDBG funds are. The cooperative agreement among the County and participating cities calls for all participants to cooperate in the allocation of HOME funds.
- 8. Since 1994, HOME funds have been used exclusively by three non-profit housing organizations:
 - PSHHC, which has developed several low income projects county-wide;

- Housing Authority of the City of San Luis Obispo (HASLO), which used HOME fund to operate the County's First-Time Homebuyers Loan Program, to operate a tenant-based rental assistance program, and to acquire an apartment building in San Luis Obispo; and
- Affordable Homes Development Corp. (AHDC), a new non-profit organization in the County, that used HOME funds to develop new ownership housing in Oceano.
- 9. The Draft One Year Action Plan, prepared by County Planning Staff with comments from the participating cities, proposes that 1999 HOME funds be spent on the following projects:

- 1. Emergency Shelter Grants (ESG) are federal funds to be used to provide shelter for the homeless.
- 2. In 1998, the urban county received \$100,000, which were allocated to the Homeless Shelter in San Luis Obispo, Homeless Day Center in San Luis Obispo, Women's Shelter in San Luis Obispo, and Women's Shelter in Atascadero.
- 3. The Draft One Year Action Plan, prepared by County Planning Staff with comments from the participating cities, proposes that 1999 ESG funds be spent on the following projects:

The Draft 1999 One-Year Action Plan describes activities proposed for funding through the County's 1999 CDBG, HOME and ESG programs.

The City of Paso Robies plans to participate in the CDBG Program and will be asked to make a recommendation to the Board of Supervisors regarding the proposed funding for the HOME and ESG Programs.

The 1999 Draft One Year Action Plan indicates that the City of Paso Robles will have the following CDBG funds available for use in 1999:

- * Paso Robles will receive *286,380 in 1998 CDBG funds and *34,000 in program income from repaid CDBG-funded loans from prior years programs for a total of *320,380 in 1999 CDBG funds:
- * Paso Robles may reprogram up to '50,000 in unspent 1997 CDBG funds that had been allocated to the Seismic Structural Design Program.

The 1999 Draft One Year Action Plan Indicates that the following activities are recommended by the City of Paso Robles for funding with the above CDBG fund:

For the 1999 CDBG allocation of \$320,380:

- * Paso Robles Youth Arts Foundation Center: *135,000;
- * Main Street's Street Lights in the Downtown: *52,000;
- * Alley Improvements in the Downtown: \$30,000;
- * George Stephan Center Program Expansion: 416,500;
- Boys and Girls Club Teen Program: ¹22,880;
 Program Administration and Capacity Building: ¹64,000;
- For up to \$50,000 in unspent 1997 CDBG tunds that may be re-programmed:
- * Handicapped Access Improvements to Classic American Theatre Building (810 - 11th Street):

The 1999 Draft One Year Action Plan indicates that the County of San Luis Obispo expects to receive allocations of *1,007,000 for the HOME Program and *100,000 for the ESG Program. The Draft One Year Action Plan does not propose funding any activities in Paso Robles with HOME or ESG funds.

The 1999 Draft One Year Action Plan, details about the recommended activities, and details about applications for CDBG funds that were not recommended for funding may be reviewed at the Community Development Department, 1000 Spring Street, Paso Robles, California between the date of publication of this notice and the date of the hearing.
