**SUBJECT:** AWARD OF BID FOR REPLACEMENT EQUIPMENT  
**DATE:** MARCH 16, 1999

**Needs:** For the City Council to award bids to purchase new equipment based on the City's Equipment Replacement Program.

- Facts:**
1. Based on the City's Equipment Replacement Program for fiscal year 1998-1999, bids were solicited for replacement equipment.
  2. Bids were received on February 17, 1999, for three pieces of equipment.
  3. Funding has been appropriated for the purchase of new equipment from the Vehicle Replacement Fund for General fund purchases.
  4. Bids on the Backhoe were reviewed and the following was determined:  
Pioneer Equipment came in as the lowest bidder, but did not meet the specifications required for the curved Lower Boom.  
Coastline Equipment came in as the second lowest bidder and met the requirements.  
Quinn Company - Met the requirements/specifications, but was the highest bidder.

**Analysis and Conclusion:**

The following pieces of equipment will replace old stock that is eligible for replacement under the adopted Vehicle and Equipment Replacement Policy:
