DATE: MAY 18, 1999

Needs: For the City Council to authorize staff to negotiate a fee and enter a Consultant Services Agreement with URS Greiner Woodward Clyde to prepare the PSR's for the Charolais Bridge alignment study and the interchange improvements at Highway 101/46 West.

 The City Council entered a Cooperative Agreement with Caltrans, SLOCOG and the County in which the City agreed to fund a Project Study Report for the interchange improvements at Highway 101/46. In exchange, Caltrans agreed to allow interim improvements to be installed as part of the development of the Target Shopping Center.

- In September 1998, City Council authorized staff to initiate consultant selection to prepare an alignment study for the southern bridge crossing or Charolais Bridge.
- Four consultants responded to the issuance of the City's Request for Proposals (RFP) for both projects.
- 4. Separate interviews with separate panel members were conducted for the two Project Study Reports. For Charolais Bridge, panel members were; Ron de Carli of SLOCOG, John McCarthy and Ditas Esperanza. For the Highway 101/46 interchange, the panel members were; Scott Eades of SLOCOG, Sarah Chesebro of Caltrans, Bob Lata and Ditas Esperanza.
- 5. Both panels rated URS Greiner Woodward Clyde as the top consultant to prepare the PSR's. Since the projects have related traffic impacts, coordination of data collection and evaluation of design alternates would be substantially enhanced and the City would realize a cost savings by having one consultant prepare both studies.
