Budget Appropriations - Year End Adjustments

DATE:

June 15, 1999

Needs:

For the City Council to consider adoption of a resolution approving year end "clean up" budget appropriations.

Facts:

- 1. During the course of the year, unforeseen circumstances arise which result in the expenditure of funds for which no budget appropriation(s) exist.
- 2. These unforeseen circumstances generally arise from direction received from the City Council in response to identifying a community need.
- 3. Other instances may arise from operational necessities which require an immediate response and it is not conducive to request a Council appropriation prior to addressing the need but are within the operational authority of the City Manager.

Analysis and Conclusion:

Generally accepted accounting principles (GAAP) requires that financial reports include certain financial statements which compare budget to actual. When there are 'budget to actual' variances, the notes to the financial report must provide an explanation. It is desirable to keep variances to a minimum, particularly as it relates to one time expenditures. It has not been the City's practice to request additional budget appropriations for small operational budget overruns. Thus, this request does not address operational budget overruns only special needs.

Staff attempts to bring unbudgeted expenditure needs to the Council for approval prior to the expenditure committment. In some instances, due to necessity, it is not possible to do so and the request will follow the expenditure committment. Sometimes, however, a one time unbudgeted expenditures slip through and are not noticed until towards the end of the year when greater scrutiny is given to overall expenditure budget.

Fiscal Impact:

There may be two different impacts depending upon the nature of the item. If the expenditure is grant reimbursable or is the result of a change in accounting practice, there is no fiscal impact. If it is not either one of these, then the expenditure may have reduced fund reserves or it may be anticipated that increased revenues will offset the one time unanticipated expenditure.

Options:

- That the Council adopt a resolution approving a various budget appropriations for the fiscal year ended June 30, 1999; or
- Ь. Amend, modify, or reject the above option.

RESOLUTION NO. 99-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES APPROVING BUDGET APPROPRIATIONS FOR VARIOUS YEAR END ADJUSTMENTS

WHEREAS, during the course of any given fiscal year, various unanticipated needs arise which may require an immediate response; or
