- **FACTS:** 1. The recently adopted FY99-00 State Budget allocated \$250,000 dollars, from the State General Fund, to be used for the construction of Barney Schwartz Park.
 - 2. Staff has received notice that the money must be requested in the form of a grant through the State Department of Parks and Recreation.
 - 3. The grant amount will be a net amount of \$246,500 due to a 1.5% fee for State Administrative overhead.
 - 4. The grant application must be accompanied by an approved resolution (see Attached).

During the FY99-00 budget process Assemblyman Able Moldanado was successful in securing \$250,000 to aid in the construction of Barney Schwartz Park. To obtain the money the City must apply for a grant through the State Department of Parks and Recreation. An approved resolution, authorizing the City Manager to request the grant, must be included in the grant application package.

ASSURANCES

Applicant possesses legal authority to apply for the grant, and to finance, acquire, and construct the proposed project, that a resolution, motion or similar action has been duly adopted or passed as an official act of the applicant's governing body authorizing the filing of the application, including all understandings and assurances contained therein, and directing and authorizing the person identified at the official representative of the applicant to act in connection with the application and to provide such additional information as may be required.

Applicant will provide and maintain competent and adequate architectural engineering supervision and inspection at the construction site to insure that the completed work conforms with the approved plans and specifications; that it will furnish progress reports and such other information as the State may require.

Applicant agrees to maintain and operate the property acquired or developed for a period commensurate with the type of project and the proportion of state grant funds and local funds allocated to the capital costs of the project.

Applicant will give the State's authorized representative access to and the right to examine all records, books, papers, or documents related to the grant.

Applicant will cause work on the project to be commenced within a reasonable time after receipt of notification from the State that funds have been approved and that the project will be prosecuted to completion with reasonable diligence.

Applicant will comply where applicable with provisions of the California Environmental Quality Act and the California Relocation Assistance Act, and any other state, and/or local laws, rules and/or regulations.
