SUBJECT: ACCEPTANCE OF PUBLIC IMPROVEMENTS FOR TRACT 1951 (MASSEY)
DATE: OCTOBER 19, 1999

Needs: That the City Council authorize the acceptance of public improvements constructed as required for Tract 1951 (Massey).

- Facts:**
1. The Subdivider entered into a Subdivision Improvement Agreement with the City and posted securities to guarantee installation of public improvements in accordance with the Subdivision Map Act and the City of El Paso de Robles Municipal Code.
 2. The Final map was approved by the City Council for recordation on September 1, 1998 by Resolution No. 98-158.
 3. The amount which shall be retained by the City during a one-year guarantee and warranty period is 10% of the Subdividers Performance securities, which is twenty-one thousand eight hundred forty-three dollars (\$21,843.00). This retention will be retained for a period of one (1) year after the acceptance of all improvements.
 4. The project was annexed into the Paso Robles Landscape & Lighting Maintenance District by Resolution 98-159.
 5. The Subdivider constructed, installed and completed the following streets or roads in accordance with the Subdivision Improvement Agreement and in compliance with the improvement plans and all applicable City standards:

Analysis and Conclusion: The public improvements which the developer was required to install have been completed. Further, the City will still retain a Maintenance Bond for a period of one year as warranty for the improvements installed.

Policy Reference: Title 22 of the Municipal Code Section and Subdivision Map Act

Fiscal Impact: City street maintenance costs will increase due to use of the City Street Sweeper during and after the maintenance period, and as a result of acceptance of these additional streets one year after the release of the maintenance securities. Maintenance costs will also increase with regard to the addition of

sewer and water main lines. These costs will vary from year to year in accordance with the amount of maintenance required. Typically, streets receive a slurry seal every five years and Asphalt overlay every twenty years. Slurry seal costs are about \$45,000 per mile and asphalt concrete overlay is about \$200,000 per mile.

- Options:**
- A. That the City Council approve the **Resolution** authorizing acceptance of certain streets into the City maintained mileage system; and approve the **Resolution** authorizing the Notice of Completion to be filed, partial release of Performance securities and release of the Payment (Labor and Materials) securities for Tract 1951 (**Massey**).
 - B. That the City Council amend, modify, or reject the above option.

**A RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF PASO ROBLES ACCEPTING CERTAIN IMPROVEMENTS
CONSTRUCTED PURSUANT TO THE SUBDIVISION IMPROVEMENT AGREEMENT
FOR TRACT 1951, AND AUTHORIZING THE CITY ENGINEER TO EXECUTE NOTICES OF
COMPLETION THEREFORE, AND TO AUTHORIZE THE RELEASE OF MAINTENANCE
SECURITIES 1 YEAR FROM DATE OF ACCEPTANCE OF PUBLIC IMPROVEMENTS**

WHEREAS, the City of El Paso de Robles and Priske-Jones, as Subdivider, entered into that certain Subdivision Improvement Agreement dated as of **September 1, 1998**, and relating to public improvement work for **Tract 1951**, in the City of El Paso de Robles; and

WHEREAS, the public improvements specially identified in **Exhibit A** attached hereto have been constructed, installed and completed by Subdivider in accordance with the Subdivision Improvement Agreement and in compliance with the improvement plans and all applicable City Standards, and the City Engineer has certified to the Council the completion of such public improvements; and

WHEREAS, Subdivider has requested that the City accept said public improvements and authorize the release of improvement securities furnished by Subdivider pursuant to the terms and conditions of the Subdivision Improvement Agreement;

THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. The public improvements, as specifically identified in **Exhibit A**, attached hereto, have been constructed, installed and completed in accordance with the Subdivision Improvement Agreement and in compliance with the improvement plans and all applicable City Standards, and the City Engineer is hereby authorized, on behalf of the City, to prepare and file a **Notice of Completion** relating to such public improvements.

Section 2. The City Engineer is hereby authorized to release the improvement securities furnished by the Subdivider in the percentages specified in the Subdivision Improvement Agreement.

Section 3. The City Engineer is hereby authorized to release the maintenance securities furnished by Subdivider one (1) year from the date of acceptance of the public improvements upon satisfactory completion of the maintenance period, as determined by the City Engineer.

Section 4. The City Clerk shall certify to the passage and adoption of this Resolution.

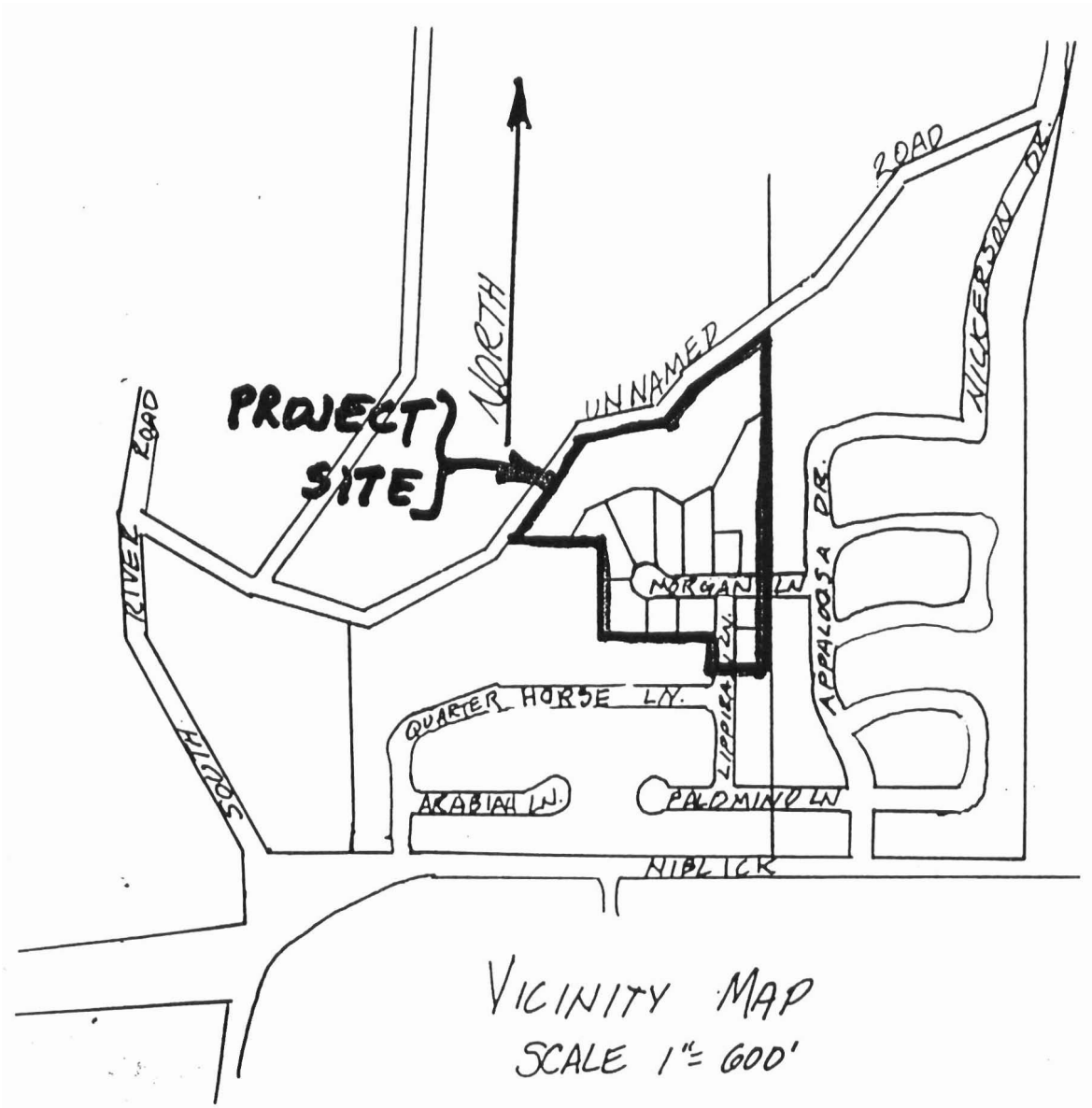
