	Needs:		
	Facts:	1.	Chapter 105 of the Uniform Building Code establishes that a Board of Appeals shall be established to pass on matters pertaining to building construction.
	Analysis and Conclusion:	2.	In conjunction with the adoption of the 1994 Uniform Building Code, Council amended Section 105 – Board of Appeals, establishing criteria for board selection, term limits and expanded the Board's authority to include the hearing of appeals associated with substandard housing and disabled access.
		3.	The amendment to the Uniform Building Code, codified under Municipal code Section 17.04.020, establishes that the board shall consist of five (5) appointed members. The Disabled Access Board of Appeals shall consist of the five (5) appointed members, supplemented by two (2) additional members, both of whom shall be physically disabled. City employees cannot be appointed to the board.
		4.	Appointments to the Board of Housing and Disabled Access Appeals were not made at the time of the code amendment.
		Appointment of a Board of Housing and Disabled Access Appeals would provide a forum to hear and decide appeals of orders, decisions or determinations made by the Building Official relative to the application and interpretation of the Codes adopted by the City of Paso Robles as follows:	
		New Construction appeals:	
		constru	could include the consideration of alternate materials, design and methods of action other than those commonly used and/or accepted to satisfy the intent of les adopted by the City.

## Substandard Housing appeals

	The board would hear appeals associated with code enforcement actions related to substandard housing and the abatement of dangerous buildings and make recommendations to the City Council, when necessary, regarding the abatement of substandard housing and/or buildings.		
	Disabled Access:		
	With the addition of two individuals, who would be disabled, the board would hear appeals pertaining to alternate means and/or methods of providing code required access for the disabled.		
	A list of potential candidates for appointment to an Interim Board (designed to serve for a 12 month period until a longer-term board can be appointed) will be forwarded under separate cover in advance of the October 19, 1999 Council meeting.
