NEEDS:

For the City Council to consider authorizing submission of a grant to the Bill & Melinda Gates Foundation (Gates Library Initiative) for library internet access computers, and accepting funds provided by the grant.

FACTS:

- 1. The Library Board of Trustees recommends submitting a Gates Library Initiative grant application to the Bill & Melinda Gates Foundation.
- 2. The Paso Robles Public Library meets all economic and demographic criteria for rural communities applying for the non-competitive grant.
- 3. The FY 1999/2000 budget currently provides for implementation of Internet service for the public. The new and expanded service allocation is for setup and continuing telecommunications costs. Budget figures were based on acquiring used computers from other city departments.
- 4. The grant request is for hardware and software including server, workstations and printer.
- 5. Since the City Council has already endorsed providing Internet to the public, this grant does not require additional obligation on the part of the city. A cover letter confirming support of the program must be signed by the library's fiscal authority to complete the grant application process.
- 6. Money will be put into the equipment replacement fund from the library's annual operating budget to provide for future replacement of hardware.
- The attached resolution provides the authority for the Paso Robles Public Library to submit a grant application and the authorization of budget program 100.610.5235.202 to receive grant funds (draft cover letter is attached).

ANALYSIS & CONCLUSION:

Authorizing this grant application will position the library to offer a higher level of service to the public than originally anticipated, with no increase in city funding. In FY 1999/2000, the City Council authorized the new and expanded service of Internet for the public. The budget allocation was based on initial set up and ongoing telecommunication costs, and the use of surplus hardware from other city departments.

Through the Gates Library Initiative, the library is eligible to receive new hardware and software for Internet access. The hardware and software specifications are compatible with the established city technology plan and standards. Establishment of budget program 100.610.5235.201 would allow the funds to be spent as required by the grant.

\$2,500 from existing annual operating budget will be set aside on an ongoing basis to provide for necessary replacements as needed.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES AUTHORIZING A GRANT APPLICATION AND APPROPRIATING FUNDS RECEIVED FOR SPECIAL LIBRARY SERVICES

WHEREAS, the Paso Robles Public Library is the potential recipient of grant money through the Gates Library Initiative for public internet access computers; and
WHEREAS, the grant money would allow the purchase of new hardware and software instead of using surplus equipment; and
WHEREAS, the new equipment will provide an augmented level of service to the community; and
WHEREAS, the grant stipulates that that monies be used to directly pay costs associated with the grant program; and
WHEREAS, the current budget did not anticipate the receipt of said grant funds; and
