SUBJECT: STREET NAME CHANGE 99013: FONTANA ROAD TO LINNE ROAD
(CITY INITIATED)

DATE: FEBRUARY 1, 2000

Needs: For the City Council to hold a public hearing and consider a request for a street name change.

- Facts:
1. The proposed name change is from Fontana Road to Linne Road. The subject street runs north-south and connects Sherwood Road to Linne Road. (see attached location map)
 2. This street name change is city initiated at the request of Emergency Services. Emergency Services has requested that Fontana Road be changed to Linne Road to reduce the number of street names the street currently has (1st, Niblick, Sherwood & Linne)
 3. Per Section 22.20.085 of the Municipal Code:

“Street name changes shall be accomplished by resolution, following the procedure for such changes as set forth in Section 5026 of the Streets and Highways Code of the State of California, provided, that prior to any street name change the city planning commission shall give notice and conduct a public hearing. The planning commission shall submit a report and recommendation to the City Council for consideration.”
 4. A street name change would be Categorically Exempt from the provisions of the California Environmental Quality Act (CEQA) under Section 15301 of the State’s Guidelines for implementing CEQA.
 5. The Planning Commission at their meeting of January 11, 2000, after testimony from Mr. Jim Wilcox who resides at 1448 Fontana, recommended denial of the street name change until the time that Sherwood Road would also change.

Analysis
and

Conclusions: Currently the street which begins as 1st Street, runs east and turns into Niblick Road at Spring Street then changes to Sherwood Road at Creston Road then to Fontana and lastly to Linne Road.

Mr. Jim Wilcox resides at 1448 Fontana Road and spoke against the renaming of Fontana Road to Linne Road, at least until Sherwood Road is also changed. The Planning Commission made a 7-0 action to recommend denial of Street Name Change 99013, and suggested that Fontana Road be considered for rename if and when Sherwood Road is requested to be changed.

Options: That the City Council hold a public hearing and after consideration of all testimony received:

- a). Based on the recommendation of the Planning Commission, determine that the proposed street name change from Fontana Road to Linne Road would not be appropriate, and approve the attached resolution denying Street Name Change 99013.
- b). Amend, modify or reject Option "a".

A RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF PASO ROBLES
DENYING STREET NAME CHANGE 99013
(FONTANA ROAD TO LINNE ROAD)

WHEREAS, Fontana Road connects Sherwood Road and Linne Road and is located near Commerce Way on the east side of the City (see attached Exhibit A); and

WHEREAS, the Emergency Services Division has requested the street name change from Fontana Road to Linne Road to reduce the number of names the street currently has; and

WHEREAS, The Planning Commission at their meeting of January 11, 2000, recommended denial of Street Name Change 99013, based on public testimony against the request, and

WHEREAS, both Government Code (section 34091.1) and Streets & Highways Code (section 5026) allows the City to change a street name, and

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. That the City Council of the City of Paso Robles does hereby deny the name change of Fontana Road to Linne Road.

SECTION 2. That the City Council of the City of Paso Robles hereby does not authorize staff to record necessary documentation with the San Luis Obispo County Clerk and San Luis Obispo County Surveyor to effect the change of street name.

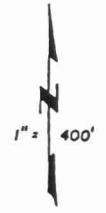

Fontana Road to Linne Road

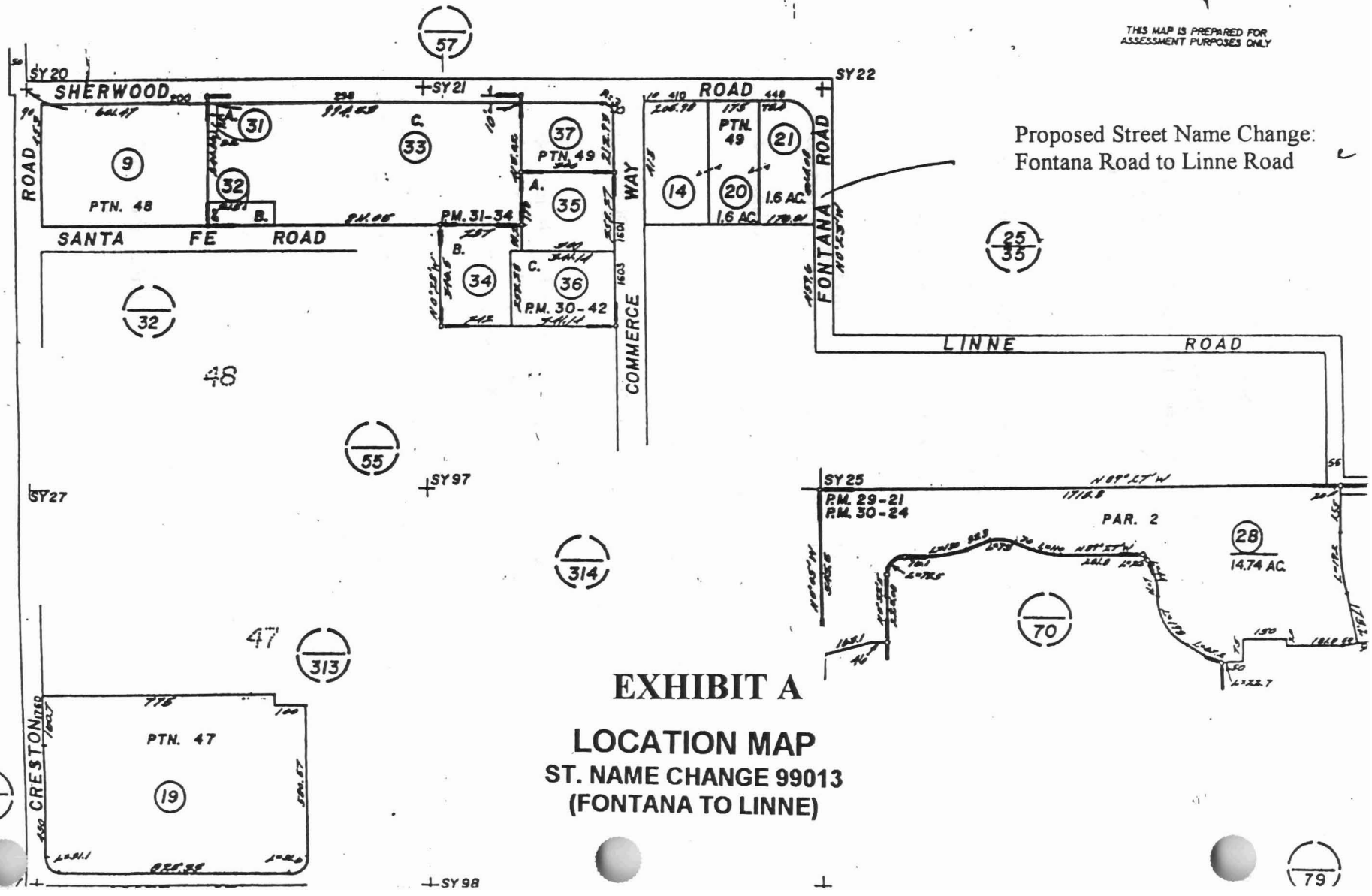


EXHIBIT A
