Conclusion:	Attached is a list of the geographic areas that have been discussed as possible additions to the City's Sphere of Influence. Based on these geographic areas, also attached is a possible workshop schedule.	
	In order to pare the number of meeting nights down from 5 to 3, it is suggested that the Council consider scheduling 2 separate workshops on two of the noted dates.

Fiscal Impact:	The inclusion of geographic areas within a proposed Sphere of Influence boundary must be justified in terms of the City's ability and willingness to provide Municipal infrastructure, facilities and services. The adequacy of funding for infrastructure, facilities and services has substantial fiscal ramifications that will receive further analysis in the near future.
