Film Restoration: Film isn't ready yet.



Chairman Kline would like to have a moment of silence and a flag salute at the meetings to get the members focused. Councilman Mecham gave suggestions of what other City Committees do at their meetings.

Member Przybyla, seconded by McNellis, moved to have the flag salute at their regular meetings. Motion unanimously passed on a 9-0 voice vote.

Member McNellis, seconded by Dahlen, moved to have a moment of silence at their regular meetings. Motion was unanimously passed on a 9-0 voice vote.

Holding Youth Commission meetings every two weeks.

Councilman Mecham advised the complications involved in meeting every two weeks and suggested to hold their regular meeting once a month and meet two weeks later for their Adhoc Committee meetings. If there was an urgent matter that needed City Council attention, Chairman Kline could give to Director to forward. He admires the Commission's energy and enthusiasm but cautions about burn out and having too much on their plate. After the regular meeting, if they have Adhoc Committee business to conduct, they can adjourn to a workshop or an informational meeting two weeks later. Director reminded members that workshops or informational meeting could get public input but no action can be taken and minutes are not taken at these meetings.

After discussion, Member Hubbard, seconded by Przybyla, moved to keep regular monthly meeting the first Wednesday of every month and if needed, they could adjourn to informational meetings. Motion was unanimously passed on a 9-0 voice vote.

Vote to re-dedicate Niblick Bridge the Gil Asa Bridge.

After much discussion, Member Hubbard, seconded by McNellis, moved for the Youth Commission to stay neutral. Motion was unanimously passed on a 9-0 voice vote.

ADHOC COMMITTEE COMMUNICATIONS

Member McNellis discussed the Brown Act and members meeting. Director advised Adhoc Committees cannot take action that effects the entire Youth Commission. Action governing this Commission in compliance with the Brown Act has to be voted on in regular session. Councilman Mecham advised Chairman Kline orchestrates and controls the Youth Commission meetings. All discussions from the Commission and public are orchestrated through the Chairman.

4. Youth Transportation Issues Concerning Youth of Paso Robles

Member Cam-Robb read a draft letter to the City Council. Commission discussed grammar changes. Member McNellis seconded by Cam-Robb, to forward letter, with corrections, to City Council. Motion was unanimously passed on a 9-0 voice vote.

5. Paso Teen Center

After brief discussion, Member Hubbard, seconded by Cam-Robb, moved to table this item to the February 16, 2000 informational workshop. Motion was unanimously passed on a 9-0 voice vote

6. Teen Health Center

Charlotte Gorton, Recreation Services Manager, discussed meeting with Director of Health Center, Jessica Estorfield. They are very interested in starting a satellite office in Paso Robles. Met in Grover Beach and gave presentation to the Youth Commission. Health Center does not charge teens a fee. There is state and grant funding and hire teens as staff. It would be up to this Youth Commission to locate this satellite office. They do want to be a part of the County Health Department for confidentiality and safe for teen to attend.

Member Smith, seconded by Przybyla, moved to table this item to the February 16, 2000 workshop. Motion was unanimously passed on a 9-0 voice vote.

Councilman Mecham asked Commission if they read and understood By-Laws. Discussed Article #4 - Officers. Member Cam-Robb would like to have the Youth Commission Liaison position added to this Article. Councilman Mecham advised these positions are appointed by the City Council.

After discussion, Member Cam-Robb, seconded by McNellis, moved to Article #4 - remain the same. Motion was unanimously passed on a 9-0 voice vote.

Member McNellis, seconded by Hubbard, under Article #5, moved to strike "on a school holiday" and to correct the Article numbering. Motion was unanimously passed on a 9-0 voice vote.

Member Dahlen, seconded by Banakis, under Article #5, moved to correct the time of meeting to 4:15 PM. Motion was unanimously passed on a 9-0 voice vote.
