Needs: For the City Council to adopt a resolution approving the terms and conditions of a Consultant Services Agreement between the City and Black & Veatch Corporation, for consulting services in conjunction with the further development and promotion of the Municipal Airport.

- Facts:**
1. The City of Paso Robles continues to operate the Municipal Airport as an essential element of the transportation services of the City.
 2. The City has determined the Airport to be an essential part of the further development of the City's economic viability.
 3. There is a definite need for the provision of additional aviation-related services at the Airport.
 4. The development of a clear Vision and associated Business Plan is essential to the further promotion of this effort.
 5. The subject consultant firm has demonstrated abilities and assets that are determined to be of benefit to the City in the pursuit of this effort.

Analysis and

Conclusion: As the City continues to work towards development of increased activity and aviation services at the Airport, it is evident that there is a need for clear direction and definition of the overall objectives and a more clear picture of the implementation process that will need to be followed. It is necessary to engage the services of outside resources, in order to provide more adequate direction to this effort.

Proposed Scope of Services

To assist the City, Black & Veatch Airport Management Consulting Group will provide the City, in connection with the planning, development, management, operation, revenue development and finances of the Airport, such general advisory airport consulting services as may, from time to time, be specifically requested and authorized by the City.

Such services may include the performance of studies, analyses, and research; participation in meetings with the City's staff and others; and the provision of other general advisory services and assistance.

Proposed Fees and General Conditions

Our experience in consulting assignments at other airports suggests that the degree of the Black & Veatch Airport Management Consulting Group's involvement and associated cost to the airport sponsor can vary significantly, depending upon such factors as (1) the duration and complexity of assignments, (2) airport management preferences as to the use of consulting services, (3) the number of unforeseen "problem areas" that come to attention during assignments. As such, we typically provide consulting services under what we refer to as a "general advisory" services arrangement. This type of arrangement is designed to be flexible and allows us to respond quickly to requests for services that a client may require.

As indicated in the previous section of this letter, the "Proposed Scope of Service" is very broad so that the client may request assistance on a wide range of matters; however, work may be performed only upon specific authorization of the client. Thus, when the client determines the need for assistance, we work out (through correspondence or by telephone) a specific scope of work and budget for that assignment, which the client then approves, before we perform any work.

The value of such a contractual arrangement is that approval of an individual contract is not required each time an assignment is identified. On the other hand, through the "assignment" approach, the client retains direct control over the scope and cost of our work.

Fees for our services would be determined on the basis of actual time and materials expended on the work (airfares, meals and lodging, printing, long distance telephone calls, postage, small package freight, and other direct costs). Fees for professional services would be billed at our current standard hourly billing rates. Our invoices would be submitted to the City on a four-week billing cycle.

It is not possible at this time to estimate, with any degree of precision, either the scope or cost of services you might require of us during the immediate future. Therefore, in order to get started, we propose establishing an initial budget of \$24,500 (including work performed to date) for our services and you can authorize specific assignments against this budget, as you deem appropriate for the circumstances.

If you desire, this letter can serve as an agreement between Black & Veatch Airport Management Consulting Group and the City to perform any of the services outlined herein, as authorized by Mr. James L. App, City Manager. Please indicate your agreement and acceptance by signing in the space provided on each copy, and return one copy to us for our files.
