SUBJECT: STREET ABANDONMENT 99-010 AND 99-011 (LUJAN AND THOMAS)

DATE: DECEMBER 3, 2002

Needs: For the City Council to consider adopting a Resolution to abandon, or a Resolution not to abandon, an 80-foot wide unimproved street as shown on the attached exhibits.

1. The Planning Commission at their meeting of November 9, 1999 recommended approval of the abandonment request.

- 2. The abandonment request was submitted by Lupe Lujan and Chris Thomas. The purpose of their request is to provide the applicants the opportunity to more fully develop their properties at Assessor Parcel Numbers 009-243-014 and 023.
- 3. The other adjacent property owner being Caltrans has written a letter of no objection to the proposed abandonment.
- 4. The City Council, at their meeting on November 5, 2002, adopted "Resolution of Intent to Abandon" No. 02-224 which set a public hearing to abandon these properties.

Analysis and Conclusion

Facts:

The requests were found to be consistent with the Streets and Highway Code and the City's General Plan. Emergency Services Staff has not raised any concerns regarding the proposed abandonment.

The City Council should, however, consider that the street right-of-ways proposed for abandonment in this application are located across 19th Street from City owned property (Pioneer Park) and therefore, for practical purposes, can be considered contiguous to park property. Further, there have been discussions regarding improvements to traffic circulation in and around the Mid-State Fair property. Although the discussions are preliminary at this time, it may be prudent for the City to retain all options that may be available to improve traffic circulation in this area.
