SUBJECT: 13th Street Bridge

DATE: December 17, 2002

NEEDS:

For the City Council to consider approving and adopting a Mitigated Negative Declaration for the proposed 13th Street Bridge Widening and Roadway Improvements.

FACTS:

- 1. This matter was continued from the November 19, 2002 City Council meeting.
- 2. The 13th Street Bridge Widening and Roadway Improvements Project is subject to the California Environmental Quality Act (CEQA). The attached Mitigated Negative Declaration was prepared and circulated to various agencies. The required public review comment period began on October 18th and concluded on November 19, 2002.
- 3. The City Council adopted an update to the City's General Plan Circulation Element on October 12, 2000. The adopted Circulation Element includes policy providing a Level of Service (LOS) of "C" as the minimum service level, providing for stable traffic flow.
- 4. In 1998, the citizens of Paso Robles passed Measure 'D', a \$38 million dollar bond measure to fund several much-needed public facilities.
- 5. One of these projects, widening of the 13th Street Bridge was included in the approved 1991 Circulation Element.
- 6. In early 1999, the City Council authorized staff to engage the services of URS Greiner, a transportation-engineering firm, to begin design of the bridge widening and adjacent streets.
- 7. On July 18, 2001, the City Council held a public hearing to evaluate and publicly discuss the final design concept. The design concepts the Council focused on met a three-fold standard: congestion relief, public safety and fiscal responsibility. The Council heard comments, approved URS' conceptual design, and directed staff to prepare construction documents (plans, specifications and estimates) for the project.
- 8. The approved design calls for widening the bridge to accommodate four travel lanes (two each way), two turn lanes, two bike lanes, and sidewalks on both sides. Beyond the bridge limits, adjacent streets (North and South River Roads, Creston Road, and Union Road) will also be widened to maximize flow at the intersection, and relieve traffic congestion
- 9. The design includes ornamental barriers and lights along the bridge, consistent with downtown design elements and those installed along the Veterans Memorial Bridge.

ANALYSIS
AND
CONCLUSION:

The City Council must review environmental impacts associated with a project before giving final approval for a project. Staff foresees the need to make project level decisions within the coming months. The following background provides a brief overview of the project (13th Street Bridge Enhancements) and the Mitigated Negative Declaration of environmental impacts is provided for City Council and public review.

Background

The engineering designs for the Project were weighed against the City's "purpose statement" and goals, which are identified in the City's General Plan (August 1991) and include traffic congestion relief, public safety, and fiscal responsibility. The City Council unanimously voted to approve the recommended best design option based on compliance with the City's goals.

The 13th Street corridor experiences high traffic demands, which leads to traffic congestion. Two-way pedestrian/bicycle accommodations need improvement to enhance and provide for all transportation modes. The Salinas River, State Route 101, and the Union Pacific Railroad run essentially parallel to each other in a northerly direction through the City limits. These three features create a physical obstacle. The downtown area of Paso Robles is located to the west of Route 101. The City and County are experiencing continued growth to the east of Route 101 and the Salinas River. Currently, the City's population is approximately 26,000. The City's current General Plan anticipates a population of 35,000. Continued growth to 35,000 will place additional traffic challenges on the bridge. The EIR produced in December 1990 for the City's 1991 General Plan Update identified the 13th Street Bridge Expansion, as well as the widening of Creston and Union Roads, as mitigation measures to address traffic impacts expected to accompany development.

Daily traffic volumes, or average daily traffic (ADT), within the Project Area of Potential Effect (APE) has been recorded between 14,830 (Creston Road as it approaches South River Road) and 15,820 (13th Street as it approaches South River Road). Due to the fact the roads within the Project APE are presently 2-lane collector roadways, this high range of ADT puts the roadways into the category LOS D, which is inconsistent with the City's traffic goals (Circulation Element Update). The improvements included in the project will return this intersection to the established service standard.

A Draft Mitigated Negative Declaration was prepared and circulated for public review. Written comments and one verbal comment were received at the public hearing on November 19, 2002. These comments were evaluated and along with the responses, have been incorporated into the Final Mitigated Negative Declaration. On the basis of this evaluation, the proposed project could have significant effects on the environment, however all of those effects will be mitigated to an insignificant level. No significant unmitigated impacts are anticipated.

POLICY

REFERENCE: 2001 Circulation Update to the General Plan; Adopted Measure 'D' Project List

FISCAL

IMPACT: The project is funded within Measure 'D' budget appropriation.

OPTIONS:

- a(1). After considering all public testimony, the City Council adopts Resolution No. 02-xx approving and adopting the Mitigated Negative Declaration for the Proposed 13th St. Bridge Widening and Roadway Improvements, making certain findings and incorporating the recommended mitigation measures as part of the proposed Project; and
 - (2). Adopt Resolution No. 02-xx approving the 13th St. Bridge Widening and Roadway Improvements as a project to be implemented, authorizing the use of the Measure D funds to pay for such project, and directing the City Clerk to cause a Notice of Determination approving the Project to be filed and posted by the Clerk of San Luis Obispo County.
- b. Amend, modify or reject the above option.
