SUBJECT:	Hayward Lumber Lease Agreement and Landscape Easement
DATE:	December 17, 2002
NEEDS:	For the City Council to consider approving a Lease Agreement with Hayward Lumber and accepting a Grant of Easement for landscape purposes.
FACTS:	1. The City applied for and was successful in receiving a \$250,000 grant to install pedestrian improvements and enhancements to the Pine Street Corridor between the Transportation Center and the Downtown District.
	2. The City Council approved a design requiring small landscape pockets on the properties along Pine Street from 7 th Street to 10 th Street. Properties along Pine Street that are affected by the project are owned by Hayward Lumber or the City. Some of the property owned by the City is leased to Hayward Lumber.
	3. Staff met with representatives of Hayward Lumber and they agreed to the final design.
ANALYSIS AND CONCLUSION:	Some of the land leased or owned by Hayward Lumber will be occupied by proposed improvements. Renewing the Lease Agreement between the City and Hayward Lumber is important to provide the City the opportunity to continue the downtown revitalization process. The City Attorney consulted with City Council and City staff, and developed a revised agreement. The Final Agreement was executed by Hayward Lumber officers. Highlights of the modified Lease Agreement are as follows:
	• The initial term of the Agreement is five years but gives Hayward Lumber the option to extend it for two additional 5-year terms.
	• Excludes a total of 192 square feet from the leased property so that the City can use these areas for landscape pockets along Pine Street.
	• Hayward Lumber will pave the remaining lease area (up to \$18,000) and costs will be reimbursed by the City. If Hayward Lumber elects to extend the term of the Agreement beyond the initial term, then 50% of the amount reimbursed by the City will be returned, amortized over the first extended 5-year term and added to the lease payment.
	• Hayward Lumber will relocate its "H" racks currently located within the proposed Landscape Pockets. The City will reimburse Hayward Lumber (up to \$15,000) to relocate these racks.
	The City Council could now authorize the Mayor to execute the Memorandum of Lease and the Lease Agreement thereby completing the lease renewal.
	In addition to the enhanced City proposals, Landscape pockets are also planned along the property owned by Hayward Lumber. Hayward Lumber has agreed to grant landscape easements, to provide for the planned landscaping, the City Council could accept this Grant of Easements for recordation.
