**SUBJECT:** Award Contract to Apply Anti-Graffiti Coating  
**DATE:** December 17, 2002

---

**NEEDS:** For the City Council to consider awarding a construction contract to apply anti-graffiti coating to the Veterans Memorial Bridge Amenities.

**FACTS:**

1. The enhancements (pilasters, walls and planters) at the Veterans Memorial Bridge were completed in April 2002.
2. Although the brick and concrete work was coated during the original project construction, the coating material used did not have an anti-graffiti component. Anti-graffiti coatings provide protection for preventing painting or easing the removal of paint, without damage to underlying masonry.
3. In accordance with the Public Works Construction Act, the City advertised for bids for the Installation of Anti-Graffiti Coating System at Veterans Memorial Bridge, providing plans and specifications to both plan rooms and all requesting individuals. All bids received by the specified deadline were publicly opened at the noticed Bid Opening on December 5, 2002.
4. Three bids were received as follows:

<b>Tim Karp Painting</b>	<b>\$15,880 (low bid)</b>
Cam Painting	\$17,499
The Brushworks	\$37,776

**ANALYSIS  
AND**

**CONCLUSION:** Installing anti-graffiti coating to the enhancements to the Veterans Memorial Bridge would prevent potential damage to these facilities. Staff ascertained the feasibility of installing anti-graffiti material without affecting the masonry appeal, then developed specifications and advertised for bids. The funding for the anti-graffiti coating project is available in the Measure D Veterans Memorial Bridge budget, Account No. 130.910.5452.738.

WHEREAS, the enhancements (pilasters, walls and planters) at the Veterans Memorial Bridge were completed in April 2002; and

WHEREAS, though any graffiti can be removed by staff, the removal process could cause permanent damage to the bricks and concrete work; and

WHEREAS, the City advertised for bids, specifications were provided to Plan Rooms and all requesting individuals, and three (3) bids were received at the Bid Opening on December 5, 2002; and

WHEREAS, the low bid submitted by Tim Karp Painting in the amount of \$15,880 is a responsive bid.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The City Council of the City of Paso Robles does hereby award a construction contract to Tim Karp Painting of Atascadero, CA in the amount of \$15,880 to apply anti-graffiti coating to the Veterans Memorial Bridge.
