For the City Council to review the schedule for the General Plan update program, and to consider options related to the ad hoc committee that will work with the consultants and staff in preparation of the Draft General Plan Elements.

meeting (to study the impacts of the largest geographic area and population scenario as a basis for determining the appropriate level of growth), the General Plan update program is now entering into its second phase.

Based on City Council direction received at the October 15, 2002, Council

- 2. Attached for your information is a description of the steps to be taken and a Draft schedule for completing the update process.
- 3. Please note that the first scheduled step in the process is sending a Notice of Preparation (NOP) and to hold a "scoping session" to start the environmental review process. In addition to starting the environmental review process, the issuance of the NOP will establish a deadline for property owners seeking to have land use changes considered within the General Plan update process.
- 4. Beyond providing an opportunity to review the proposed schedule, the purpose of this report is to seek City Council direction regarding the composition of the ad hoc committee that will work with the City's consultants and staff in preparation of the Draft General Plan text.

Analysis and Conclusion:

As the attached schedule indicates, there will be a number of workshop meetings to formulate and refine the Draft text of the General Plan. These are anticipated to be relatively long work sessions.

The proposed approach is to review, discuss and confirm each detail of the existing Land Use and Circulation Elements, and to have the consultants prepare the additional draft elements based on the same format as the current Land Use and Circulation Elements.

As the program is now structured (based on prior Council direction), the Parks & Recreation Advisory Committee would recommend a Draft Parks & Recreation Element update. In turn, the full Planning Commission and City Council would meet together and work with the consultants and staff to both review the P&R Element and to prepare the balance of the Draft General Plan Elements.

Needs:

Facts:

Based on Council's prior direction, staff's understanding is that the Council may wish to use the full City Council and Planning Commission as the ad hoc Committee that would work with the consultants and staff in confirming and formulating General Plan text. Under this approach, each workshop meeting would be a combined adjourned regular meeting of the full City Council and Planning Commission.

In light of the number of meetings and the amount of time that would necessarily be devoted to preparing the Draft General Plan Elements, the Council could also consider the option of appointing a subcommittee (ad hoc committee). For example, the Council could appoint two Councilmembers and allow the Planning Commission to appoint up to three Commissioners to help formulate a recommended Draft General Plan (which would be subject to confirmation by the full Planning Commission and City Council).

Under this option, a designated subcommittee could work with the consultants and staff to formulate recommended text for the General Plan. The recommended text could then be scheduled for noticed public workshop meetings with the full City Council and Planning Commission (e.g. once every three months during the General Plan program).

Options:

- a. For the City Council to (1) review and comment on the proposed work schedule for the second half of the General Plan update program (including the date of Thursday, January 9, 2003, for the EIR scoping session and the deadline for private property requests for General Plan Amendments); (2) appoint a two-member City Council representation to a General Plan ad hoc committee, which would report back to the full City Council on a periodic basis and provide a final report prior to 12/31/03; and (3) request that the Planning Commission appoint three members to the same ad hoc committee. Staff would confirm the meeting dates with the ad hoc committee and provide the necessary public notice for workshop dates. Public workshops with the full City Council and Planning Commission would be scheduled every three months.
- b. For the City Council to (1) review and comment on the proposed work schedule for the second half of the General Plan update program (including the date of Thursday, January 9, 2003, for the EIR scoping session and the deadline for private property requests for General Plan Amendments); and (2) for the City Council to confirm that it wishes to use the full City Council and Planning Commission as the ad hoc committee to work on the Draft General Plan elements. A schedule for future workshop meetings would be brought back for City Council consideration at the January 7, 2003 Council meeting.
- c. Amend, modify or reject the foregoing options.

This schedule anticipates the time that will probably be needed to work with the General Plan ad hoc Committee in formulating Draft General Plan text. Please note that:

- If the process moves more quickly than anticipated, the City's consultants and staff will be prepared to condense the schedule / work program.
- The amount / level of detail of discussions will help determine the speed with which the process proceeds.

Ad hoc committee meeting #1:

- Review of status of General Plan work program and timeline for completion
- Review of process and timeline for preparing Environmental Impact Report on General Plan update program
- Review of process components (including role of Parks & Recreation Advisory Committee, relationship to Airport Master Plan/Land Use Plan)
- Review of Planning Commission recommendation that was confirmed by City Council on October 15, 2002
- Review of private property owner requests for land use changes in conjunction with the General Plan update process, as well as City staff recommendations regarding refinement of and/or changes to multi-family residential land use designations and development densities
