### 1. AB 1600 - Development Impact Fee Study

A public workshop to formally review proposed adjustments to the City's development impact fees. (Under discussion will be pending adjustments to the City's Development Impact Fees, pursuant to State Assembly Bill 1600. Development impact fees would pay for infrastructure [roads and other facilities] that would be needed to accommodate future growth and development. Fees would be applied to new developments to pay for their proportionate shares of these infrastructure costs.)

Mayor Mecham opened the public hearing. Speaking from the public were Jerry Bunin (Home Builders Association), Nick Ferravanti, Tom Rusch and Debra Smith. There were no further comments from the public, either written or oral, and the public discussion was closed.

Councilmember Heggarty, seconded by Councilmember Finigan, moved to direct staff to return to the February 18, 2003, City Council meeting with an ordinance implementing new development impact fees, including that version of the fees which eliminates the costs associated with equipment that has a useful life of six years or less. Motion passed by the following unanimous roll call vote:
