FACTS:	1. Currently, the City employs a contractor to clean City facilities via a janitorial services contract. The current contract will soon expire, so bids were solicited for janitorial services for the following City facilities:								
	Public Safety Center City Hall/Library Centennial Park Activity Center Centennial Park Norris Gymnasium Centennial Park Pool, Office and Locker Room Paso Robles Youth Arts building Airport Terminal North County Transportation Center (Multi-Modal facility) Senior Activity Center, and Veterans Center								
	2. The contract term will begin April 1, 2003 and end June 30, 2003. Pending adoption of the FY04/05 budget, the contract will continue until June 30, 2005.								
	3. Bid specifications were available and advertised since November 25, 2002. Specifications were provided to all requesting individuals and Notice Inviting Bids was published twice in a local publication.								
	4. Four (4) bids were received at the Bid Opening on February 13, 2003. The bids ranged from a low bid of \$13,045 per month to a high bid of \$16,445 per month.								
	5. The low bid of \$13,045 per month, submitted by North County Industries (NCI), was reviewed and deemed a responsive bid. In accordance with the City Purchasing and Payment Procedures Manual, award to the low responsive bidder is indicated.								
ANALYSIS									
AND CONCLUSION:	Currently the City owns and occupies buildings ranging from 400 square foot Parks restrooms to a 40,000 square foot Public Safety Building. To ensure that building users encounter a pleasant environment, the buildings must be cleaned regularly and properly.								
	The contract specifications include the custodial basics (dusting, litter removal, restroom cleaning) as well as the more complex janitorial jobs (machine scrubbing of hard floors, cleaning of interior/exterior windows, carpet care and cleaning). Regular inspection by City staff will monitor the contractor for compliance. To insure quality workers and service, the contract contains language requiring all on-site workers to undergo background checks before employment and wear badges identifying them as janitorial employees while working in or around a City facility.
