<u>Needs</u> :	For the City Council to consider a \$17,550 appropriation for payment of economic incentive pursuant to an existing agreement with JIT Manufacturing.
<u>Facts</u> :	1. The Council previously approved economic incentive agreements with JIT Manufacturing.
	2. The agreement provided for a building permit fee waiver and a performance incentive based upon net annual gains in employment
	3. In fiscal year 2001, JIT Manufacturing received a building permit fee waiver of \$13,000.
	4. During the first performance year, JIT Manufacturing received an incentive payment of \$8,250 based upon net annual gains in employment.
	5. For the second and third years, JIT Manufacturing has provided satisfactory documentation of net annual gains in employment that call for an incentive payment totaling \$17,550.
<u>Analysis</u> <u>and</u> Completions	
<u>Conclusion</u> :	It is desirable that the Council appropriate funds from the Economic Incentive Fund to cover the economic incentive payment to be made to JIT Manufacturing.
	The economic incentive due this business has resulted in new indirect reocurring revenues to the City's General Fund.
<u>Fiscal</u> Impost	
<u>Impact</u> :	There are sufficient funds in the Economic Incentive Fund to cover the requested budget appropriation. The Economic Incentive Fund has a balance of \$775,700 as of February, 2003.
<u>Options</u> :	a. Adopt Resolution No. 03-xxx approving a budget appropriation in the amount of \$17,550 from the Economic Incentive Fund; or
	b. Amend, modify, or reject the above option.

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES APPROVING A BUDGET APPROPRIATION FOR THE CITY'S ECONOMIC INCENTIVE PAYMENT TO JIT MANUFACTURING
