For the City Council to consider adopting a "Resolution of Intent" to abandon an unimproved Needs: variable width portion of Vine Street right-of-way as shown on the attached exhibit "A". Facts: 1. The Planning Commission at their meeting of March 25, 2003 recommended approval of the abandonment request. 2. The abandonment request was submitted by Dry Creek Partners. The purpose of their request is to accommodate their proposed commercial development, PD 02-017, at the southeast corner of Vine and 1st Streets (Assessor Parcel Number 009-821-006). Analysis and Conclusion The request was found to be consistent with the Streets and Highway Code and the City's General Plan. Emergency Services Staff has not raised any concerns regarding the proposed abandonment. The area proposed to be abandoned is right-of-way in excess of the 80-foot right-of-way alignment consistent with Vine Street to the north of 1st Street. 
