


- **Needs**: That the City Council consider steps toward finalizing development plans for a residential development and subdivision.
- **Facts:** Applicant Margaret Pemberton has requested that Parcel Map PR 01-355 be accepted by the City for recordation. PR 01-355 is located at 1650 Kleck Road.

At their meeting of May 20, 2003, the City Council approved the applicant's request to maintain a well on the property for agricultural purposes subject to recordation of constructive notice of termination of such approval upon sale or further development of the property. Said constructive notice has been submitted and will record with the parcel map.

Analysis and Conclusion:		Map PR 01-355 was tentatively approved by the Planning Commission on 12, 2002. All conditions imposed by the Planning Commission have been ed.
