Exhibit "A"
Legal Description

That portion of Lot 13 of the Rancho Santa Ysabel in the City of El Paso de Robles, County of San Luis Obispo, State of California, as per the Map recorded January 25, 1887 in Book A of Maps, at Page 29, records of said County and described in the Deed to Heer recorded November 23rd, 1956 in Book 870 of Official Records, at Page 440, records of said County, lying southwesterly of the following described line:

Commencing at corner "SY 110" in the southerly line of said Lot 13, said corner being on the center of County Road No. 91 (also known as Creston Road) marked by a Brass Cap stamped "RCE 31581";

Thence along the centerline of said road, North 74°25'12" West, a distance of 209.90 feet;

Thence South 87°05'02" West, a distance of 354.29 feet;

Thence North 72°58'22" West, a distance of 246.00 feet to a point in said centerline of County Road No. 91, which point is the most southwesterly corner of the property conveyed to L.N. Kleck et. ux. by deed dated September 27, 1946, and recorded October 3, 1946, in Book 421, at Page 320 of Official Records;

Thence leaving said centerline, North 9°40'38" East along the westerly line of said Kleck Deed, a distance of 68.56 feet to the beginning of a non-tangent curve concave to the south having a radius of 642.39 feet from which a radial line bears South 19°02'08" West and being the True Point of Beginning;

Thence westerly along said curve through a central angle of 22°19'06", a distance of 250.23 feet to the beginning of a reverse curve concave to the north having a radius of 30.18 feet from which a radial line bears North 03°16'58" West;


Thence westerly and northwesterly along said curve through a central angle of 62°08'24", a distance of 32.73 feet to a point on the westerly line of said Heer Deed, from which a radial line bears North 58°51'26" East, said point being the Point of Terminus.

EXCEPT THEREFROM that portion lying within the Creston Road Plan Line as described in the Deed recorded in Book 1411 of Official Records, at Page 320 and shown on the Record of Survey recorded in Book 15 of Licensed Surveys, at Page 59, records of said County.

Contains 9,228 square feet, more or less.

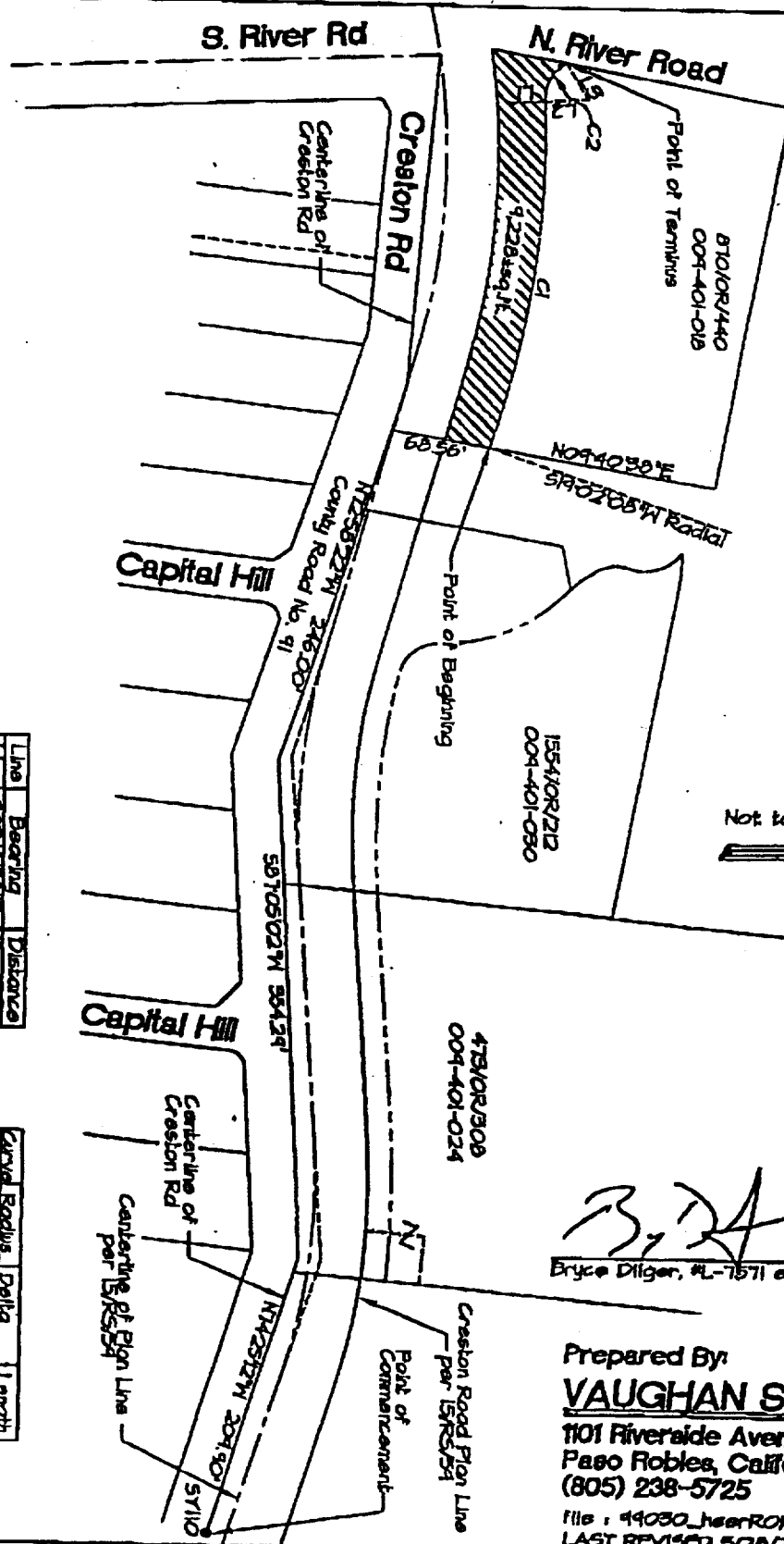

Exhibit A-1 Map

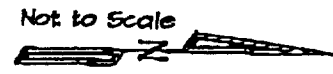

Kleck et. ux. by deed dated September 27, 1948, and recorded October 3, 1946, in Book 421, at Page 320 of Official Records;

Thence leaving said centerline, North 9°40'38" East along the westerly line of said Kleck Deed, a distance of 68.56 feet to the beginning of a non-tangent curve concave to the south having a radius of 642.39 feet from which a radial line bears South 19°02'08" West and being the True Point of Beginning;

Thence westerly along said curve through a central angle of 22°19'06", a distance of 250.23 feet to the beginning of a reverse curve concave to the north having a radius of 30.18 feet from which a radial line bears North 03°16'58" West;

Thence westerly and northwesterly along said curve through a central angle of 62°08'24", a distance of 32.73 feet to a point on the westerly line of said Heer Deed, from which a radial line bears North 58°51'26" East;

Thence along said westerly line North 10°32'10" East, a distance of 155.09 feet to the southwesterly line of said Kleck Deed;

Thence along said southwesterly line, South 80°19'22" East, a distance of 93.83 feet;

Thence South 28°32'57" West, a distance of 138.68 feet;

Thence North 89°29'20" East, a distance of 109.99 feet;


Thence South 71°48'00" East, a distance of 119.90 feet to the westerly line of said Kleck Deed;

Thence along said westerly line South 9°40'38" West, a distance of 27.41 feet to the Point of Beginning.

Contains 18,088 square feet, more or less.

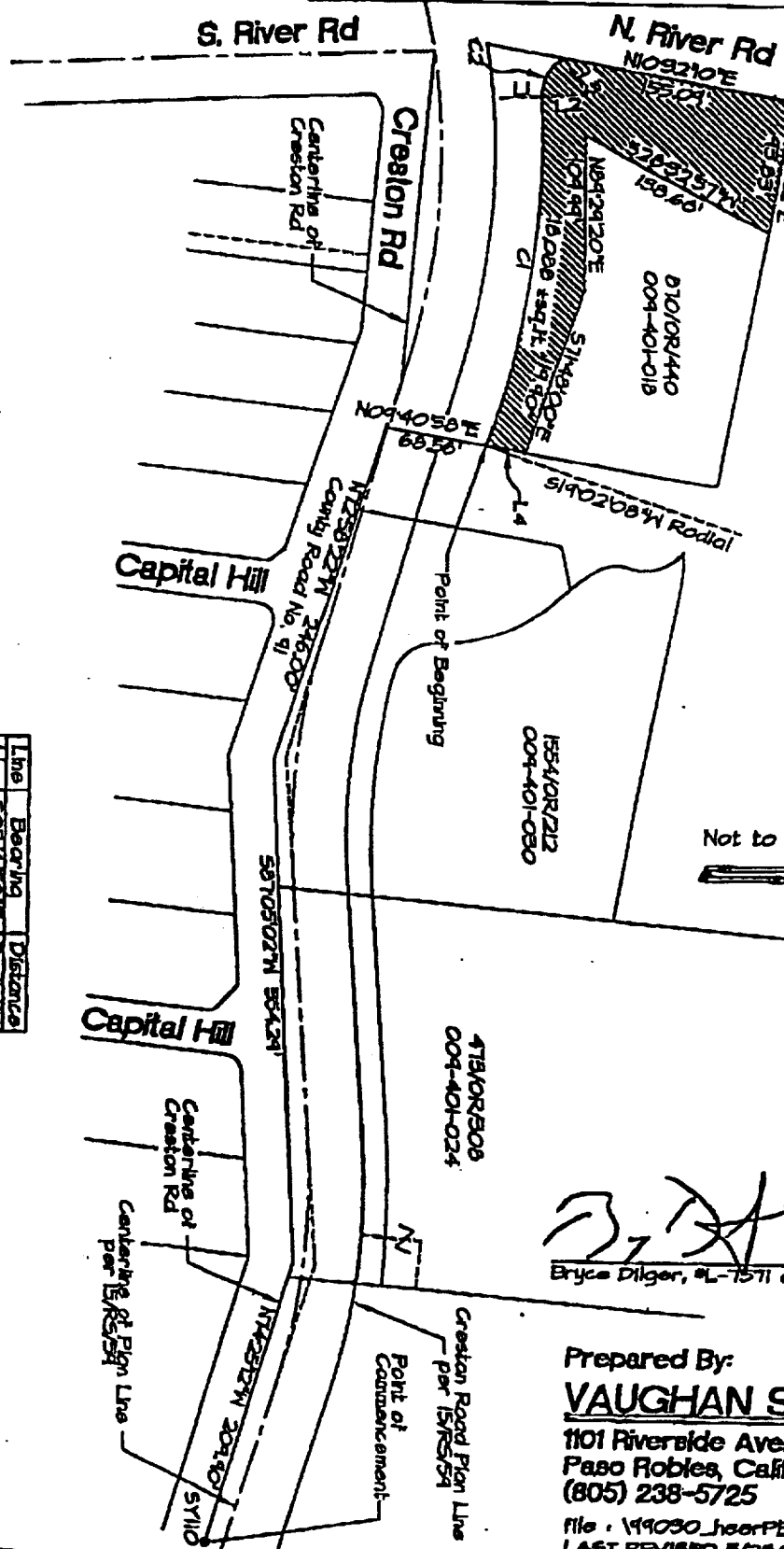
