NEEDS: For the City Council to consider installation of one stop sign on Jackson Drive at the

intersection of Shannon Hill Drive.

FACTS: 1. At the May 23, 2003, Streets and Utilities Committee meeting, the Committee voted 2-0 to recommend a stop control on Jackson Drive at Shannon Hill Drive.

ANALYSIS & CONCLUSION:

Jackson Drive and Shannon Hill Drive converge at a three-way uncontrolled intersection. Potential site distance challenges are present from two of three approaches:

 Westbound Shannon Hill Drive traffic sight distance is affected by a steep uphill incline.

- Southbound Jackson Drive sight distance is affected by a steep uphill incline.
- Eastbound Shannon Hill Drive has adequate sight distance to the intersection.

The Committee recommends a stop control on Jackson Drive to increase the safety of the intersection. Placement of the stop sign could be made to optimize the view to motorists stopped on Jackson Drive, of both eastbound and westbound traffic on Shannon Hill Drive.
