SUBJECT: Traffic Controls on 15th Street West of Vine Street to City Limits

DATE: July 15, 2003

NEEDS: For the City Council to consider traffic controls (stop signs, edge lines, signage and

crosswalk) on 15th Street West of Vine Street to the City limits.

FACTS: 1. The City received a letter and petition from concerned citizens requesting stop signs at three intersections on 15th Street, west of Vine Street. The Streets and

Utilities Committee considered the request at their meeting on May 23, 2003. The Committee voted 2-0 to recommend stop controls on 15th Street at the Chestnut Street intersection and 15th Street at the Filbert Street

Street at the Chestnut Street intersection, two (2) additional 25mph speed limit

intersection.

2. The City received a second letter on June 10, 2003, requesting additions to the Streets and Utilities Committee's recommended actions. The Streets and Utilities Committee considered the additional requests at their meeting on June 27, 2003. The Committee voted 2-0 to add additional controls which include edge lines on both sides of 15th Street from Vine Street to the City Limits, a crosswalk on 15th

signs and (2) Children at Play signs (2).

ANALYSIS & CONCLUSION:

Analysis

15th Street west of Vine Street is a wide road with a substantial grade change. Eastbound motorists tend to pick up speed rapidly because of the road width and the severe downhill grade. Westbound motorists are challenged to see ahead because of the road's undulations and tend to speed in an attempt to get up the steep incline. These conditions appear to pose a potential risk to motorists, pedestrians and animals.

Conclusion

In consideration of neighborhood residents, motorists and pedestrians traveling and/or crossing $15^{\rm th}$ Street, it is recommended that the suggested traffic control improvements be approved.

- Two (2) 25mph speed limit signs (locations to be determined by staff)
- Two (2) Children at Play signs (locations to be determined by staff)
