SUBJECT: Annual Street Maintenance – Remaining Budget

DATE: July 15, 2003

NEEDS:

For the City Council to consider a recommendation from the Streets and Utilities Committee regarding the remaining budget in the Annual Street Maintenance project.

FACTS:

- 1. The Streets and Utilities Committee recommended, and City Council approved, rehabilitating certain streets (7 reaches) under the 2003 Street Maintenance project. These 7 street reaches (see attachment, bolded Line Items 5, 7, 8, 10, 14, 16, and 17) were, before bidding, estimated to cost \$420,000.
- 2. The actual low bid of \$305,000 left \$95,000 (from the \$400,000 budget) available for additional paving work, or other street-related projects, at City Council's discretion. The Streets and Utilities Committee looked at several options, including adding paving projects, addressing various street-related projects, or carrying the balance forward to next fiscal year.
- 3. The Capital Improvement Project (CIP) budget was adopted by the City Council on June 3, 2003. The CIP budget includes several non-paving projects funded with future Transit Development Act (TDA) funds, including:
 - Install (12) handicap ramps: (6) downtown and (6) at other locations \$60,000
 - Install a raised median at 6th and Spring Streets \$20,000
 - Install (4) additional speed humps at Rambouillet Road and
 - (3) at Nicklaus Drive (after Omni-Means traffic calming study) \$24,500
 - Design fee to develop pedestrian walkway for fairgrounds
 Airport Road median modifications by Bonita Homes
 \$20,000

ANALYSIS AND

CONCLUSION:

The Streets and Utilities Committee recommends that the City Council allocate the remaining \$95,000 available from the 2003 Annual Street Maintenance Budget to:

- Install (12) handicap ramps, and
- Install (4) additional speed humps at Rambouillet Road and (3) additional speed humps at Nicklaus Drive

In addition, the Committee directed staff to get updated information from the Fair administration on the pedestrian walkway improvements, and if the Fair was in a position to carry out the construction, to return with more specifics on the City design project.

IMPACT:

 $\$95,\!000$ is available from the 2003 Annual Street Maintenance Budget to fund the recommended projects.

- Install (4) additional speed humps at Rambouillet Road and (3) additional speed humps at Nicklaus Drive
