## **RESOLUTION NO. 03 -**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES ACCEPTING PUBLIC IMPROVEMENTS FOR TRACT 2369-1 (FALLINGSTAR HOMES, INC., LOTS 1-71) CONSTRUCTED PURSUANT TO THE SUBDIVISION IMPROVEMENT AGREEMENT, AUTHORIZING RELEASE OF THE PAYMENT AND PERFORMANCE BONDS, AND AUTHORIZING RELEASE OF MAINTENANCE SECURITIES ONE YEAR FROM DATE OF ACCEPTANCE OF THE PUBLIC IMPROVEMENTS

WHEREAS, Tract 2369-1 was accepted June 4, 2002, for recordation, and a Subdivision Improvement Agreement was entered into; and

WHEREAS, all public improvements required as Conditions of Approval for this subdivision have been constructed in compliance with the improvement plans and all applicable City Standards, and the City Engineer has certified to the Council the completion of such public improvements; and

WHEREAS, the Subdivider has constructed, installed or completed the following streets or roads in accordance with the Subdivision Improvement Agreement, the improvement plans and all applicable City Standards:

WHEREAS, Subdivider has requested that the City accept said public improvements and authorize the release of improvement securities furnished by Subdivider pursuant to the terms and conditions of the Subdivision Improvement Agreement.

## THEREFORE, BE IT RESOLVED AS FOLLOWS:

<u>SECTION 1.</u> Upon completion of all public improvements to the satisfaction of the City Engineer, that the public improvements constructed as required for Tract 2369-1 be accepted into the City's maintenance system, approximately 0.97 miles in length, upon the release of maintenance securities, and the City shall then assume responsibility for their future maintenance and repair. The Subdivider shall be obligated for maintenance of all public improvements for a period of at least one year from date of acceptance by the City Council. After one year, maintenance securities may be released by the City Engineer upon completion of all correction items to the satisfaction of City staff.

<u>SECTION 2</u>. That upon receipt of a maintenance bond in the amount of \$445,529 the payment bond \$2,227,643 and the performance bond \$4,455,285 guaranteeing construction of these public improvements may be released.
