**SUBJECT:** Parking Restrictions (Red Curb) on Theater Drive

**DATE:** August 19, 2003

**NEEDS:** For the City Council to consider parking restrictions (red curb) on Theater Drive.

FACTS:

- 1. The City received a letter regarding unsafe ingress and egress from San Luis Bay Motors (on Theater Drive) due to cars parked on the curb limiting site line visibility. Of particular concern are the truck access driveways to San Luis Bay Motors and Boatman's Furniture properties.
- 2. The Streets and Utilities Committee considered the request at their June 27, 2003 meeting to restrict parking on Theater Drive. The Committee voted 1-0, with Councilman Picanco abstaining, to recommend City Council approval of the suggested red curbs.
- 3. Further site review revealed the need to consider additional red curb to maintain consistency and traffic safety along Theater Drive. The issue was presented again to the Committee on July 27, 2003. The Committee voted 1-0 to amend the red curb installations on Theater Drive previously recommended. All affected property owners present voiced support for the recommendations.

### ANALYSIS & CONCLUSION:

A Study of Theater Drive, south of the Highway 46 intersection to City Limits has revealed unsafe traffic conditions. If cars are parked on the street near entry/exit points, traffic ingress and egress site distance is considerably less than the 400 feet necessary for safe entry into traffic traveling at speeds in excess of 45 mph. To mitigate this site line problem, restricted parking (red curbs) is recommended.

### Conclusion

After study of the area and public testimony, all parties (property owners and Streets & Utilities Committee) agree that the installation of red curbs appears to be the most effective means to increase traffic safety along the portion of Theatre Drive in question.
