SUBJECT: All-Way Stop at the Intersection of 8th Street & Oak Street

DATE: August 19, 2003

NEEDS: For the City Council to consider installation of traffic controls (stop signs) at the intersection of 8th and Oak Streets.

FACTS: 1. At a Planning Commission public hearing regarding the office professional FPA and Zoning overlay for Oak Street between 8th and 9th Streets, a citizen testified, promoting

the need for an all-way stop at the intersection of 8th and Oak Streets.

2. At the May 23, 2003 meeting of the Streets and Utilities Committee, the issue was discussed briefly then continued to the June meeting to allow research regarding the issues.

3. At the July 27, 2003 meeting of the Street and Utilities Committee, the issue was discussed a second time. After discussion, the Committee voted to recommend the installation of traffic controls (all-way stop) at the intersection of 8th Street and Oak Street.

ANALYSIS
AND
CONCLUSION:

The 8th and Oak Street intersection is currently controlled by stop signs at 8th Street on the east and west sides of Oak Street. Two sightline obstructions (a hedge and large oak tree) are located at the southeast corner of the intersection.

Two possible safety enhancements were discussed at the July 27th meeting of the Streets and Utilities Committee: 1) removal of the hedge and installation 90 feet of red curb south of the large oak tree and/or, 2) the addition of stop signs on Oak Street at the north and south sides of the 8th and Oak Street intersection (results in an all way stop intersection).

Red Curb

The hedge and the large oak tree on the southeast corner of 8th and Oak Streets present a sightline challenge. Westbound traffic appropriately stopped on 8th Street must look south between the hedge and the oak tree to see northbound traffic on Oak Street, or inch their way out into the intersection to look to the south and west of the large oak to attempt to see northbound traffic. If a vehicle is parked on the curb north of the oak tree on Oak Street the westbound motorist on 8th Street has no choice but to inch their way out into the intersection to view northbound traffic on Oak Street. Removing the hedge and installing 90 feet of red curb on the north side of the large oak tree would enhance sightline.

All-way Stop

Stop signs could be installed, which would mitigate the sightline issue. Traffic from all directions would be required to stop, giving the westbound traffic on 8th street a better opportunity to see the northbound traffic on Oak Street.

Conclusion

The Committee opted to recommend installation of an all-way stop as the best option. It meets both the need for safety enhancement (all cars must stop mitigating the site line issues) and the need to retain the hedge (beautification consideration) while retaining the on street parking for area businesses.
