SUBJECT: Municipal Pool Renovations
DATE: January 20, 2004

NEEDS: For the City Council to consider awarding the construction contract for the Municipal Pool Changing Room Project

FACTS:

1. In 2001, 2002, and 2003, the City applied for and obtained Community Development Block Grant (CDBG) funds to perform construction work at the Municipal Pool Changing Room.
2. In 2001, the City Council directed staff to engage the services of Sawyer Architects to develop a phased Master Plan to rehabilitate the Municipal Pool Changing Room and surrounding areas.
3. In May 2003, staff presented three alternatives for the City Council to consider for a first phase construction project. The City Council directed staff to prepare construction documents to address the following improvements to the facilities:
 - Handicap accessibility in the parking lot area
 - Handicap accessibility in showers, toilets, plumbing fixtures and other miscellaneous equipment to be replaced with related plumbing to match
 - Paint/improve interior walls
 - Provide lockers
 - Minor improvements to exterior eaves and rafters.
4. In addition, the bid documents included additive bid items to fully improve the roof to provide the City the option to add this work if available funding is sufficient to allow it.

**ANALYSIS
AND**

CONCLUSION: In accordance with the Public Contract Code, bid documents were provided to plan rooms and to individuals requesting them. At the Bid Opening on January 8, 2004, two (2) bids were received: \$203,500 and \$244,400.

The low bid was submitted by Newton Construction & Management, Inc. in the amount of \$203,500. City staff reviewed the bid documents, and finds the bid responsive.

POLICY

REFERENCE: Adopted Capital Improvement Program; Public Contract Code.

FISCAL

IMPACT: A budget of \$250,000 has been appropriated and approved under Budget No. 601/221.910.5452.576 for this project. There is a balance of about \$217,000 available for the construction phase.

OPTIONS:

- a. For the City Council to adopt Resolution No. 04-xxx awarding a contract to Newton Construction & Management, Inc. in the amount of \$203,500 for the Municipal Pool Changing Room project.

b. Amend, modify, or reject the above option.
