**Needs:** That the City Council authorize the acceptance of an Easement Grant Deed of a landscape and tree easement provided by Bermant Development Company related to the development of Tract 2254-3 located on Silver Oak Drive, east of Creston Road.

**Facts:** 1. The City has received an Easement Grant Deed for a variable width landscape and tree easement adjacent to the east side of City owned Lot A, on a portion of Lot 65, Tract 2254-3.

**Conclusion:** As part of the development of Tract 2254-1, the City accepted the Offer of Dedication of Lot A on the Final Tract Map which accommodated the development of a storm water detention basin. Adjacent to Lot A, Bermant Development has provided an Easement Grant Deed for the maintenance of landscaping, by the Landscape and Lighting District, of a variable width strip of land on Lot 65 of Tract 2254-3. The dedication of the easement does not affect the owner's ability to reasonably develop and use the subject property. (see Exhibit "B")

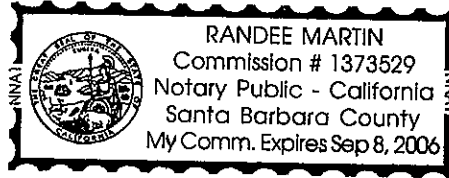


