SUBJECT: ADD DONALD F. RODRIGUES TO THE CITY'S PRE-APPROVED CERTIFIED ARBORIST LIST
DATE: MARCH 16, 2004

Needs: For the City Council to consider adding one new Arborist to the City's Certified Arborist consultant list. This list is available for City staff use and as a public handout, and is required to be adopted under Chapter 10.01, the Oak Tree Protection ordinance.

- Facts:
1. Chapter 10.01.040 of the City Municipal code requires that a person who provides services as an arborist in the City must be certified by the Western Chapter of the International Society of Arboriculture (ISA) and must be on a list of certified arborists approved by the City Council.
 2. The purpose of the pre-approved arborist consultant list is to ensure that only ISA-certified arborists are used by applicants in addressing oak tree issues.
 3. The following Arborists have requested to be added to the City's List to do work within the City boundaries:

Donald F. Rodrigues, ISA Certificate Arborist: 272
 4. The arborists returned a signed statement acknowledging that he understand the conditions under which the City will accept him for approval on the List (on file in the Community Development Department).
 5. Staff has reviewed the qualifications for Mr. Rodrigues and found that he is qualified to provide consulting services and to prepare arborist reports to the City pursuant to Chapter 10.01 requirements.

Analysis
and
Conclusion:

The Oak Tree Protection Ordinance (Municipal Code Chapter 10.01) was amended in September 2002 to strengthen the protection of oaks in the City of Paso Robles. The amended code requires that an arborist consulting in the City must be certified by the ISA as qualified to determine whether an oak tree is diseased, and able to make recommendations regarding pruning, cutting, and preservation measures.

Mr. Rodrigues was sent a copy of the Oak Tree Protection Ordinance and Oak Tree Evaluation Criteria, and was asked to sign a statement that they he had read the Ordinance and agree to conform to the City's criteria for evaluation reports. He responded in writing to provide their certification number and current address/telephone and e-mail information. In addition, Mr. Rodrigues was advised of the need to obtain a City Business License to perform work in the City.

Fiscal
Impact: Adopting an updated arborist consultant list would expedite the process of selecting a qualified consultant for both the applicant and for City-initiated projects.

Options:

- a. Adopt the Resolution No. 04-xx adding Donald Rodrigues to the City's pre-approved arborist consultant list (Exhibit A).
- b. Amend, modify, or reject above option.

NOW, THEREFORE, BE IT FOUND, DETERMINED AND RESOLVED by the City Council of the City of El Paso de Robles to adopt the attached revised pre-approved ISA-Certified Arborist consultant list adding Donald F. Rodrigues to the list (Exhibit A).
