

RESOLUTION NO. 05-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES ANNEXING PD 02-003 AS PART OF SUBAREA 94 TO THE "PASO ROBLES LANDSCAPE AND LIGHTING DISTRICT NO. 1" (STREETS AND HIGHWAYS CODE SECTIONS 22500, ET SEQ.)

WHEREAS, the owner of the real property described in Exhibit 'A' has petitioned for annex PD 02-003 into the Paso Robles Landscape and Lighting District No. 1 ("District").

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED as follows:

<u>SECTION 1</u>. That the City Council of the City of Paso Robles does hereby declare that the real property located in the City of Paso Robles, County of San Luis Obispo, as more particularly described in Exhibit 'A' hereto, is hereby annexed into the District and that all landscape and lighting improvements required as conditions of approval of PD 02-003 be installed by the developer.

<u>SECTION 2</u>. That the City Council of the City of Paso Robles does hereby declare that the current owners of the real property, according to the Petition for Formation of the District, are East Village Associates, LLC, and Hastings Family Trust.

<u>SECTION 3.</u> That the City Council for the City of Paso Robles does hereby declare that the assessment for PD 02-003 shall begin with Fiscal Year 2006-2007.

<u>SECTION 4.</u> That the City Council for the City of Paso Robles does hereby declare that the area annexed shall be designated Paso Robles Landscape and Lighting District No. 1, as part of Sub-Area 94.
