

SUBJECT:	Acceptance of Offer of Dedication and Grant of Easement (Lamb, Spring Street)
DATE:	February 15, 2005
Needs:	That the City Council authorize the acceptance of an Irrevocable and Perpetual Offer of Dedication for public road purposes and a Grant of Easement for temporary construction purposes provided by Robert Lamb related to the development of a residential duplex at 3016 Spring Street.
Facts:	1. The City has received a two-foot wide Irrevocable and Perpetual Offer of Dedication for public road purposes adjacent to property at 3016 Spring Street.
	2. The City has received a 20-foot wide Grant of Easement for temporary reconstruction of a driveway and grading to accommodate street improvements on property located at 3016 Spring Street.
Analysis And	
Conclusion:	Robert Lamb has requested occupancy of a residential duplex located at 3016 Spring Street. In order to satisfy the conditions of approval of PD 03-014 Lamb is required to construct widening of Spring Street. Lamb's frontage is the only parcel on the east side of Spring Street between 30 <sup>th</sup> Street and 32 <sup>nd</sup> Street that is currently subject to this requirement. Constructing the improvements at this time would create significant transition issues with adjacent properties. Therefore, Lamb has chosen to make a deposit to the City's curb and gutter fund in lieu of the construction.
	A two-foot offer of dedication of public right-of-way is required along Lamb's frontage in accordance with the Spring Street Master Plan. A Grant of Easement for temporary construction of a new driveway and grading is necessary to accommodate the new improvements at the time they are ultimately constructed.
