DATE: February 15, 2005

NEEDS:

For the City Council to consider awarding a contract to install improvements at Centennial Park.

FACTS:

- 1. In October 2001, the City Council authorized staff to apply for the Roberti Z'Berg Harris Grant. On June 18, 2002, the City Council accepted a \$500,000 grant and appropriated \$214,000 in City matching funds.
- 2. In September 2004, the City received approval of an additional \$69,863 grant for the project. Therefore, the total project budget is \$783,863, although the \$69,863 grant has not yet been formally added to the project budget.
- 3. In May 2003, the City Council approved the project design and authorized staff to prepare construction documents and advertised for bids.
- 4. When the bids opened on May 20, 2004, only one bid was received (in the amount of over one million dollars). The bid was rejected and staff re-structured the bid documents and re-advertised.
- 5. Revised bid documents were prepared segregating items between "Base Bid" and "Alternate Bid" categories.
- 6. At the bid opening on January 20, 2005, three bids were received (see attached Bid Summary tabulation).

WHEREAS, at the bid opening on January 20, 2005, three bids were received with the following base bids:

Wysong Construction \$ 571,900 Newton Construction \$ 671,700 Anderson Burton Construction \$ 718,500.

THEREFORE. BE IT RESOLVED AS FOLLOWS:

<u>SECTION 1.</u> The City Council of the City of El Paso de Robles does hereby appropriate \$69,900 from additional grants received to Budget No. 216.910.5452.429.

<u>SECTION 2.</u> The City Council of the City of El Paso de Robles does hereby accept staff's recommendation to award the contract to Wysong Construction for the Centennial Park project as follows: (a) Base Bid, \$571,900; (b) Interior Painting of Gym, \$42,400; (c) Refinish Gym Floor, \$18,500; for a total amount of \$632,800.

<u>SECTION 3.</u> The City Council of the City of El Paso de Robles does hereby authorize the City Manager to enter a contract with Wysong Construction in the amount of \$632,800.
