SUBJECT: Contract Award to Install New Traffic Signal at 24th and Vine
DATE: March 1, 2005

NEEDS: For the City Council to consider adopting Resolution No. 05-xx to award a contract to install a new traffic signal at 24th and Vine Street.

FACTS:

1. The need for this traffic signal was identified in 2001, and the City Council appropriated \$200,000 to install a new traffic signal at 24th and Vine as part of the adopted Capital Improvement Program.
2. On August 3, 2004, the City Council authorized the City Manager to engage the services of TPG Consulting to prepare the construction documents for this signal.

**ANALYSIS
AND**

CONCLUSION: Staff advertised for bids for the construction of the traffic signal. At the bid opening on February 17, 2005, only one bid was received, from Lee Wilson Electric Co., Inc., in the amount of \$179,300. Staff has reviewed the bid and found it to be a responsive bid.

POLICY

FISCAL

IMPACT: A budget of \$200,000 was established under Budget Account No. 214.910.5452.525. The balance remaining at the time of this request for bid award is \$192,000.

OPTIONS:

- a. Adopt Resolution No. 05-xx authorizing the City Manager to enter into a construction contract with Lee Wilson Electric Co., Inc., in the amount of \$179,300 to install a new traffic signal at 24th and Vine, under Budget No. 214.910.5452.525.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES
AWARDING A CONTRACT TO INSTALL A NEW TRAFFIC SIGNAL AT 24TH AND VINE

WHEREAS, the City Council has appropriated \$200,000 in Budget No. 214.910.5452.525 to install a new traffic signal at 24th and Vine Street; and

WHEREAS, the City Manager was authorized by City Council on August 3, 2004 to engage the services of TPG Consulting to prepare construction documents; and

WHEREAS, there is a balance of \$192,000 in Budget No. 214.910.5452.525, and this amount is sufficient to cover the cost of the proposed signal; and

WHEREAS, at the Bid Opening on February 17, 2005, one bid was received, from Lee Wilson Electric Co., Inc., in the amount of \$179,300; and

WHEREAS, the bid was reviewed by staff and found to be a responsive bid.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. That the City Council does hereby award the construction contract to Lee Wilson Electric Co., Inc. of Arroyo Grande in the amount of \$179,300.

SECTION 2. The City Council of the City of Paso Robles does hereby authorize the City Manager to enter into a contract with Lee Wilson Electric Co., Inc. in the amount of \$179,300 to install a new traffic signal at 24th and Vine Street, under Budget No. 214.910.5452.525.
