SUBJECT: Emergency Bank Stabilization Project for the Thunderbird Well Field

DATE: April 19, 2005

NEEDS:

For the City Council to authorize payment for emergency bank stabilization work at the Thunderbird well field.

FACTS:

- 1. The rain storms in early January caused the Salinas River to quickly rise and significantly erode the river bank east of the Thunderbird well field. During the peak of the storm, the bank erosion rate was approximately one foot per hour.
- 2. An area approximately 800' foot long by 50' wide by 20' deep (equal to approximately 30,000 cubic yards of soil) was lost. Based on the saturated ground conditions and the forecast for additional rain, quick action was needed to stop further erosion and avoid losing one or more of the Thunderbird wells. The erosion warranted the immediate shut down of well #10.
- 3. Prior to beginning the bank stabilization work, staff conferred with regulatory agencies, including the California Dept of Fish and Game.
- 4. The scope of the bank stabilization work exceeded City capabilities. Due to the emergency situation, the services of a local contractor were retained. Work was initiated on January 10 and continued through January 14.

ANALYSIS AND

CONCLUSION:

The bank stabilization work was required as an emergency measure to maintain the integrity of the Thunderbird well field.

POLICY

FISCAL IMPACT:

The water operations operating budget does not have sufficient capacity to absorb this unexpected expense. An additional budget appropriation is required to cover

the expense.

Assuming worst case scenario that all budgeted appropriations are expended and that recently updated revenue projections are collected, the following results for Water Operations are projected:
