NEEDS:

For the City Council to consider adopting Resolution No. 05-xx to award the construction contract for the Mitigation Planting Plan of the 13th Street Bridge Project.

FACTS:

- 1. On December 17, 2002 the City Council adopted the Final Mitigated Negative Declaration of the 13th Street Bridge Widening Project.
- 2. Since the project required work within the waters of the United States, including wetlands, the City filed for and obtained a permit from the U.S. Army Corp of Engineers.
- 3. As a condition of the permit, the City was required to submit a Mitigation Planting Plan to the Army Corps of Engineers for their review and approval.
- On January 22, 2004, the City received notice that the Army Corp approved the City's Mitigation Planting Plan.
- 5. The Plan requires the City to collect seedlings at the project site and plant in a nursery. Once construction is complete, these seedlings would be re-planted at the site and monitored for five (5) years to insure maturity and growth.

Bid Documents were prepared and advertised to perform the work in accordance to the approved Mitigation Planting Plan.

At the bid opening on April 7, 2005, only one bid was received, from Plowboy Landscapes, Inc., in the amount of \$162,203. Staff has reviewed the bid and found it to be a responsive bid

WHEREAS, funds for this work have been included in the budget adopted for the 13th Street Bridge Widening Project.

THEREFORE, BE IT RESOLVED AS FOLLOWS:
