**SUBJECT:** Street Abandonment 04-006 (38<sup>th</sup> Street, Vernon)

**DATE:** May 3, 2005

Needs:

For the City Council to hold a public hearing to consider adopting a resolution abandoning an unimproved variable width portion of 38<sup>th</sup> Street right-of-way between Vine Street and Oak Street as shown on the attached exhibit "A".

Facts:

- 1. The abandonment request was submitted by Brad Vernon. The purpose of the request is to expand residential use of the parcels adjacent to the abandoned area.
- 2. The Planning Commission at their meeting of January 25, 2005, in a unanimous decision, recommended denial of the abandonment request.
- 3. The City Council, at their meeting of April 5, 2005, adopted Resolution No. 05-072, a Notice of Intention to Abandon a portion of 38<sup>th</sup> Street, which set a public hearing date of May 3, 2005 to consider the street abandonment request.
- 4. Pursuant to Streets and Highways Code 8323, Notice of this Hearing was duly published in the Telegram Tribune, a newspaper published and circulated with the City of Paso Robles.
- 5. Pursuant to Streets and Highways Code 8323, two (2) weeks before the date set for this hearing, Notice of Vacation was posted along the line of 38<sup>th</sup> Street.
- 6. 38<sup>th</sup> Street is a roughly developed gravel road. The existing grade of 38<sup>th</sup> Street does not conform to City Standards for vertical profiles.
- 7. A City Standard Road could not be built in the existing right-of-way without significant alteration of the existing terrain.

#### Analysis and Conclusion

The subject request was found to be consistent with the Streets and Highway Code and the City's General Plan. Emergency Services Staff has not raised any concerns regarding the proposed abandonment.

The Planning Commission recommended denial of the proposed street abandonment on a unanimous vote. The Commission determined that 38<sup>th</sup> Street was useful as a connection between Vine and Oak Streets. The Planning

Commission was not presented with detailed information regarding the current condition of 38<sup>th</sup> Street and the constraints associated with its ultimate development as a City Street.

The existing terrain in the 38<sup>th</sup> Street right-of-way drops off of the edge of paving on Vine Street at a slope in excess of 20 percent. In accordance with City Standards, a street should slope at no more than 3 percent for the first 20 feet beyond the curb line of an intersecting street; and then no more than 15 percent beyond that point. Substantial alteration of existing grades, including fill in excess of 10 feet in vertical height, would be necessary to bring 38<sup>th</sup> Street into conformance with City Standards.

Due to the existing condition of 38<sup>th</sup> Street, it would appear that the City would benefit from the abandonment of the street by the elimination of a safety hazard.

The northerly half of the right-of-way of 38<sup>th</sup> Street is owned in fee by the City by virtue of a quit claim deed from Caltrans. The abandonment of the street right-of-way provides the City with the opportunity to benefit by the proceeds of transferring the property, should the City choose to do so.

The request is consistent with the Streets and Highway Code and the City's General Plan. Emergency Services staff has not expressed concerns with the proposed abandonment.

It is recommended that public easements be retained for the maintenance of existing sewer and water lines.


