PUBLIC COMMENTS

- Chuck Miller announced that "The Wings of Freedom" tour will be celebrating the 60th
 Anniversary of WWII in Paso Robles at the Municipal Airport May 11-13. The Boeing B-17
 Flying Fortress and the Consolidated B-24 Liberator will be on display at the Estrella Warbirds
 Museum.
- Martin Wagner raised concerns about setbacks in "The Cottages Development" next to his home.
- Don Simoneau, Advisor of the Paso Robles Youth Motorsports, introduced his race team and solicited support for the team.
- Housing Program Manager Ed Gallagher announced that Paso Robles, with a population of 28,000, is now the second largest city in the County of San Luis Obispo.

• Interim Public Works Director Doug Monn announced that notices to owners of unreinforced masonry structures subject to City of Paso Robles Municipal Code Chapter 17.18 were sent out on May 3rd. To date, there are eight owners currently not in compliance.

PUBLIC HEARINGS

1. Street Abandonment 04-006 (38th Street - Vernon)

R. Lata, Community Development Director

Consider abandoning an unimproved variable width portion of 38th Street right-of-way between Vine and Oak Streets. (Applicant Brad Vernon submitted this abandonment request for the purpose of expanding residential use of the parcels adjacent to the proposed abandonment area.)

Mayor Mecham opened the public hearing. Speaking from the public were Brad Vernon (applicant) and Tom Flynn. There were no further comments from the public, either written or oral, and the public hearing was closed.

Councilmember Heggarty, seconded by Councilmember Strong, moved to return item to the Planning Commission. Motion was withdrawn.

Councilmember Picanco moved to adopt Resolution No. 05-xx denying the request of the applicant to abandon 38th Street between Vine and Oak Streets. Motion failed due to a lack of a second.

Councilmember Heggarty, seconded by Councilmember Strong, moved to adopt Resolution No. 05-090 abandoning 38th Street right-of-way between Vine and Oak Streets, but retain public easements for water and sewer as shown on Exhibit A.

2. Code Amendment 04-007: Multiple Family Residential Regulations

Consider a City-initiated amendment to the Zoning Code to revise the multiple family residential development regulations. (This amendment would establish development regulations for residential multiple family developments of 20 units per acre.) CONTINUED FROM APRIL 5, 2005

Mayor Mecham opened the public hearing. Speaking from the public was Amy Wagner. There were no further comments from the public, either written or oral, and the public hearing was closed.

Councilmember Nemeth, seconded by Councilmember Strong, moved to (1) adopt Resolution No. 05-091 approving a Negative Declaration for Code Amendment 04-007; and (2) introduce for first reading Ordinance No. XXX N.S. amending the Zoning Code to revise multiple family residential development regulations; and set May 17, 2005, as the date for adoption of said Ordinance.

Adopt Resolution No. 05-094 authorizing the recordation of Tract 2593, and authorizing the Mayor to execute the Subdivision Improvement Agreement guaranteeing the construction of the subdivision improvements, with an established deadline of May 3, 2007, to complete these improvements; and adopt Resolution No. 05-095 annexing Tract 2593 into the Landscape and Lighting District. (Applicants: Highlands Paso Robles, LLC. This is a 55-lot subdivision located along the westerly extension of Red Cloud Road and the northerly extension of Navajo Avenue. Applicants have signed a petition and voted in favor of annexation into the L&LD.)

11. Request to Remove Oak Tree - 1733 Mesa Road (Gomez)

R. Lata, Community Development Director

Consider approving request to remove one Blue Oak tree at 1733 Mesa Road. (Applicant Tara Gomez is requesting the removal of one 16-inch Blue Oak on her property. Arborist Ted Elder recommends the tree be removed as soon as possible, as the outer bark of the tree is destroyed from past fire damage, has signs of rot and burrowing insects, as well as an infestation of woodworm.)

Mayor Mecham opened the public hearing. Speaking from the public was Mike Menath. There were no further comments from the public, either written or oral, and the public discussion was closed.

Councilmember Picanco, seconded by Councilmember Heggarty, moved to adopt Resolution No. 05-96 approving the oak tree removal request based on the findings, conclusions, and recommendations of the Arborist Report identifying the tree as being in poor condition; and require that three Blue Oak (3) 1.5-inch diameter replacement trees be planted at the direction of the arborist.

12. Use of Septic System - 3340 Airport Road (Handley)

Consider allowing septic tank and leach field usage for the construction of an agricultural accessory building at 3340 Airport Road, north of Highway 46 and south of Dry Creek Road. (The nearest available sanitary sewer main is at the intersection of Dry Creek Road and Airport Road, approximately one-half mile to the north.

Mayor Mecham opened the public hearing. There were no comments from the public, either written or oral, and the public discussion was closed.

Councilmember Nemeth, seconded by Councilmember Heggarty, moved to adopt Resolution No. 05-097 authorizing use of a septic system for an agricultural accessory building at 3340 Airport Road (APN 025-431-077/Handley) subject to Conditions "a" through "k" as stated in Municipal Code Section 14.08.070 K 4 "Conditions."

13. Condition of Approval Regarding Participation in Community Facilities District or Equivalent Mitigation

Consider the text of a revised standard condition of approval in relation to mitigation of fiscal impacts created by new residential development. (The proposed revision to the standard condition of approval on discretionary applications creating new residential units is intended to provide fiscal mitigation even if, for whatever reason, participation in a Community Facilities District [CFD] is not feasible.)

Mayor Mecham opened the public hearing. There were no comments from the public, either written or oral, and the public discussion was closed.

Councilmember Heggarty, seconded by Councilmember Strong, moved to approve the proposed standard condition for fiscal impact mitigation, focusing on a CFD, but providing alternative mitigation.

14. Initiate Proceedings for Annual Levy of Landscape & Lighting District Fiscal Year 2005-2006

D. Monn, Interim Public Works Director

Consider initiating proceedings for annual levy of the Landscape & Lighting District for fiscal year 2005/2006. (A Landscape and Lighting District was formed in 1989 for the maintenance of streetlights, hardscapes, detention basins, parkways, median islands, open space, slopes, and other appurtenant facilities and operations relating to the L&L District. Adoption of the Engineer's Levy Report to allow assessment occurs between April and June of each year, and it is forwarded to the County by the end of June, so that it can be included in property tax assessments.)

Mayor Mecham opened the public hearing. There were no comments from the public, either written or oral, and the public discussion was closed.

Councilmember Nemeth, seconded by Councilmember Heggarty, moved to (1) adopt Resolution No. 05-098 initiating proceedings for the Annual Levy for the maintenance of District facilities; and (2) adopt Resolution No. 05-099 declaring the Intent to Levy and cause a notice to be published for a public hearing to be scheduled on June 7, 2005; and (3) adopt Resolution No. 05-100 adopting the Draft Preliminary Engineer's Levy Report as presented and making it available to the public for review and comment

15. Emergency Services Reserve Firefighter and Volunteer Programs

K. Johnson, Chief of Emergency Services

Consider initiating a Reserve Firefighter Program. (In April 2004, the volunteer firefighter program was concluded due to increasing Federal and State training and certification demands placed on volunteers. The Emergency Services Department has examined several alternatives to volunteer firefighters in meeting the medical, fire, and rescue needs of the community. It was determined that a program similar to that employed by the Police Department represented the best solution.)

Mayor Mecham opened the public hearing. There were no comments from the public, either written or oral, and the public discussion was closed.

Councilmember Strong, seconded by Councilmember Nemeth, moved to authorize the Emergency Services Chief to proceed with initiating a Reserve Firefighter Program as presented.
