CONSTRUCTION BUILDING PLANS

DATE: JUNE 7, 2005

Needs: For the City Council to consider appropriating funds to cover the costs associated with

the electronic archiving of building plans and documents.

Facts:

1. The State health and Safety code requires jurisdictions to archive copies of building plans associated with commercial, industrial, and multi-family development.

2. The Building Division contracts conversion of building plans and documents to an outside vendor.

- 3. The cost for this service is collected from the developer by resolution and deposited in General Ledger Account No. 100-000-4739-000.
- 4. At the end of each budget year, an allocation is required to cover the cost of electronic archiving for that year.

Analysis & Conclusion:

The cost of electronic archiving are collected from the developer. The City can comply with the need to archive plans without impacting the General Fund.

<u>Policy</u>

<u>Fiscal</u> <u>Impact:</u>

t: General Fund Reserve for Electronic Archiving in an amount of \$16,800 for fiscal year 2005.

The one year budget/four-year financial plan adopted by the Council on May 4, 2004 indicated that the General Fund would experience a \$(976,000) operating deficit for fiscal year 2005 and would increase to \$(1,242,500) by the end of fiscal year 2008.

Due to the passage of Proposition 1A, the City's General Fund benefited significantly. The revised General Fund projections for fiscal year 2005 reduce the deficit to \$(345,200) for the current fiscal year.

Since July 1, 2004, the Council has approved the following additional General Fund budget appropriations:

These additional appropriations plus this request for \$16,800 would increase the projected General Fund deficit to \$(1,398,100). The projected deficit will be paid from General Fund savings (reserves).

- **b.** Amend, modify, or reject the option above.
