SUBJECT: Award Construction Contract to Pave Runways and Taxiways at the Municipal Airport
DATE: July 5, 2005

NEEDS: For the City Council to consider awarding a contract to pave runways and taxiways at the Municipal Airport.

FACTS:

1. The City has an FAA Grant to perform on-going paving maintenance of the runways and taxiways at the Municipal Airport.
2. Construction documents were prepared and staff advertised for bids for this year's paving maintenance.
3. At the bid opening on May 19, 2005, only one bid was received, from R. Burke Corporation in the amount of \$937,480.05.

**ANALYSIS
AND**

CONCLUSION: Staff reviewed the one bid received and forwarded it to the FAA for their review and approval. They determined that the bid received is consistent with their guidelines and the provisions of the Grant. It is therefore recommended that the City Council direct staff to award the contract to R. Burke Corporation in the amount of \$937,480.05.

POLICY

FISCAL

IMPACT: The FAA Grant funds 95% of the project, the State Aviation Grant Programs funds 4.5%, and the remainder will be funded from the Airport Enterprise Fund as adopted in the Capital Improvement Program.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES
AWARDING A CONTRACT TO PAVE RUNWAYS AND TAXIWAYS
AT THE MUNICIPAL AIRPORT

WHEREAS, the City has an FAA Grant to perform on-going paving maintenance of the runways and taxiways at the Municipal Airport; and

WHEREAS, construction documents were prepared and staff advertised for bids for this year's paving maintenance; and

WHEREAS, at the bid opening on May 19, 2005, only one bid was received, from R. Burke Corporation in the amount of \$937,480.05; and

WHEREAS, staff reviewed the one bid received and forwarded it to the Federal Aviation Administration (FAA) for their review and approval; and

WHEREAS, the FAA determined that the bid received is consistent with their guidelines and the provisions of their Grant; and

WHEREAS, costs for this contract are funded as follows: 95% from FAA Grant funds, 4.5% from State Aviation Grant Programs funds, and the remainder from the Airport Enterprise Fund as adopted in the adopted Capital Improvement Budget.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The City Council of the City of Paso Robles does hereby award the contract to R. Burke Corporation of San Luis Obispo in the amount of \$937,480.05 to pave runways and taxiways at the Municipal Airport.

SECTION 2. The City Council of the City of Paso Robles does hereby authorize the City Manager to enter into a contract with R. Burke Corporation in the amount of \$937,480.05.
