SUBJECT: Street Abandonment 04-003 (Oak Street, Morris-Cardinale)

DATE: July 19, 2005

- **Needs:** For the City Council to hold a public hearing to consider adopting a Resolution to abandon a portion of Oak Street from 3rd Street to 4th Street, an 80-foot wide street, as shown on the attached Exhibit "A".
- **Facts:** 1. The portion of Oak Street being considered for abandonment lies between 3rd Street and 4th Street. Oak Street in undeveloped at this location. The topography includes steep slopes and a significant drainage course.
 - 2. The abandonment request was submitted by Richard Morris and Joe Cardinale. The purpose of the request is to allow for residential uses.
 - 3. The Planning Commission at their meeting of May 24, 2004 recommended approval of the abandonment request in a unanimous decision.
 - 4. The City Council, at their meeting on June 7, 2005, adopted "Resolution of Intent to Abandon" No. 05-117 which set a public hearing to abandon this right-of-way.
 - 5. Pursuant to Streets and Highways Code §8323, Notice of this Hearing was duly published in the Telegram Tribune, a newspaper published and circulated within the City of El Paso de Robles.
 - 6. Pursuant to Streets and Highways Code §8323, two (2) weeks before the date set for this hearing, Notice of Vacation was posted along the line of 19th Street.
 - 7. At the July 5, 2005 Council meeting, the request for continuance was made on behalf of the City Engineer so that he would be available to attend the public hearing.

Conclusion The request would appear to be consistent with the Streets and Highway Code and the City's General Plan. Emergency Services staff has not raised any concerns regarding the proposed abandonment.

It is necessary that private access and utility easements be recorded prior to or simultaneously with the street abandonment to maintain access to two existing parcels along this section of Oak Street. The City will abandon the existing 4-inch water line that currently exists in the subject right-of-way.
