For the City Council to consider appropriating additional funds to pay for Needs:

contract services related to the establishment of the City's Community

Facilities District.

1. On April 5, 2005, the City Council took the final steps necessary to establish a Community Facilities District (CFD) to mitigate the costs of providing City services to new residential development.

> 2. The process of adopting the City's CFD was made significantly more expensive than the original budget as a result of the time and costs related to meeting with representatives of the Home Builders Association (HBA) and responding to a series of inquiries that the HBA posed between summer 2004 and spring 2005.

> 3. The requested appropriation would close out the budget for David Taussig and Associates (DTA) regarding preparation of the CFD.

Analysis and Conclusion:

Formation of the CFD was consistent with the General Plan policy of "fiscal neutrality" and will over the long run be an essential component in the City's ability to pay for services demanded by new residential development.

Throughout the process of establishing the CFD the City and its consultant sought to be responsive to inquiries and requests for meetings made by the HBA. Those responses required additional work, conference calls, and face-toface meetings between DTA, City staff, the City Council ad hoc Committee, and HBA representatives. DTA also up-dated the City's Fiscal Impact Analysis model, incorporating new housing data provided by the HBA.

Facts:

The original budget appropriations for establishment of the CFD totals \$130,230. Based on actual time and materials expended by DTA, the total cost was \$145,430.

The request is for an appropriation of \$15,200 to pay for the balance of the contract services related to formation of the City's CFD.

Policy

Reference: General Plan policy of "fiscal neutrality"

Fiscal

Impact:

In the short term, the \$15,200 will be a direct impact on General Fund reserves. Over the longer term, the establishment of the CFD was essential to insuring the City's ability to provide services to new residential development. It is proposed that the City's expenditures of \$145,430 for the establishment of the CFD be reimbursed through future CFD payments.

Options:

- For the City Council to approve the Resolution No. 05-xx appropriating a. \$15,200 from General Fund Reserves to pay for contract services related to formation of the City's CFD and authorize the Director of Administrative Services to establish a reimbursement to the City's General Fund regarding the \$145,430 costs of establishing the CFD.
- b. Amend, modify or reject the foregoing options.
