SUBJECT: Bid Award - Monthly Cleaning of Transit Stops

DATE: **August 16, 2005**

NEEDS:

For the City Council to consider awarding a contract to NCI Affiliates, Inc. (NCI) for the monthly cleaning of all City transit stops.

FACTS:

- The City transit system currently has 26 stops ranging from a simple bench to a fully covered shelter with bench, lighting and trash receptacle. Routine cleaning is needed to keep the stops functional and attractive.
- In an attempt to purchase cleaning services at the most economical price, bids were solicited for monthly cleaning of each transit stop.
- Specifications were prepared and advertised per the City of Paso Robles Purchasing and Payment Procedures Manual.
- 4. 2 bids were received and opened on July 14, 2005 in the amounts of \$10,920 and \$12,744 per year.
- The low bid of \$10,900 submitted by NCI Affiliates, Inc. was reviewed and deemed responsive.

ANALYSIS

AND

CONCLUSION: Historically, monthly cleaning of transit stops was not provided for in the Public Works Budget. However, because the City transit stops are an integral part of the City's transportation system and overall appearance of the City, the City Council asked staff to secure costs for monthly cleaning services and report the costs back to the Council for consideration.

POLICY

FISCAL

IMPACT:

When the Fiscal Year 2006 budget was adopted, Council requested investigation of costs to undertake needed cleaning. The quoted cost may be appropriated from Transit Operations Fund, however, as the Transportation Development Act (TDA) claim for fiscal year 2006 has not yet been prepared, approved by Council nor filed with the San Luis Obispo Council of Governments, the amount and availability of TDA funding is yet undetermined. Funding may require any adjustment to the portion of TDA funds allocated to street and roads.

OPTIONS: a. Approve Resolution No. 05-xx:

- 1) Awarding the contract for monthly cleaning of the transit stops to NCI Affiliates, Inc. in the amount of \$10,900 per year;
- 2) Authorizing the City Manager to execute said contract, and
- 3) Approving a budget allocation from the Transit Operations Fund (Transportation Development Act funds) to Budget Account No. 206-140-5221-131.
- **b.** Amend, modify, or reject the above option.
