**DATE:** October 18, 2005

**NEEDS**: For the City Council to consider awarding a contract to restore the landscaping at the

slope below the Golden Hill Road tanks which were damaged as a result of the San

Simeon earthquake.

**FACTS:** 1. The San Simeon earthquake of 2003 damaged the Golden Hill water tanks.

2. The down slope flow of water from the tanks damaged the landscaping along its path.

3. City staff included the cost of the damaged landscaping as part of the total cost to

repair the tanks.

4. Staff prepared construction documents for the slope landscaping restoration project

and advertised for bids.

5. At the bid opening on September 22, only one bid was received, from Martinelli Landscape Construction in the amount of \$151,000. Staff reviewed the bid and found

it to be a responsive bid.

**ANALYSIS**

**CONCLUSION:** It will be necessary to install the landscaping to return the tank site to pre-earthquake

conditions. FEMA will reimburse the City for this cost.

## **RESOLUTION NO. 05-**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES AWARDING A CONTRACT TO RESTORE THE LANDSCAPING AT THE SLOPE BELOW THE GOLDEN HILL ROAD TANKS (EARTHQUAKE RELATED)

WHEREAS, during the San Simeon earthquake, the City released water from the Golden Hill Road tanks when it appeared that the tanks were damaged, and the large amount of water damaged the landscaping along the slopes; and

WHEREAS, City staff submitted the cost to restore the landscaping to FEMA, and they included it as part of the costs to repair the damaged tanks; and

WHEREAS, staff prepared plans and specifications to restore the landscaping at the slope below the Golden Hill Road tanks, and advertised the project for bid; and

WHEREAS, at the bid opening on September 22, 2005, only one bid was received, from Martinelli Landscape Construction in the amount of \$151,000; and

WHEREAS, the one bid, submitted by Martinelli Landscape Construction of Templeton, was reviewed and found to be a responsive bid.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

<u>SECTION 1.</u> The City Council of the City of Paso Robles does hereby award the contract to Martinelli Landscape Construction in the amount of \$151,000 to restore the landscaping at the slope below the Golden Hill Road tanks (Budget Account No. 100.820.5452.257/258).

<u>SECTION 2.</u> The City Council of the City of Paso Robles does hereby authorize the City Manager to enter into a contract with Martinelli Landscape Construction in the amount of \$151,000.
