
Corrected wording:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES ANNEXING TRACT 2369-4 (FALLINGSTAR HOMES) AS PART OF SUBAREA 69D TO THE "PASO ROBLES LANDSCAPE AND LIGHTING DISTRICT NO. 1" (STREETS AND HIGHWAYS CODE SECTIONS 22500, ET SEQ.)
