SUBJECT: Yearly Vehicle and Equipment Purchases
DATE: January 17, 2006

NEEDS: For the City Council to consider authorizing staff to purchase new vehicles based on the City's Equipment Replacement Program.

FACTS: 1. The following vehicles are authorized for replacement purchase in the FY06 budget and funded in the Vehicle Replacement Fund.

2. Bids were received and opened December 8, 2005 for five **(6)** mid-size used cars; one **(1)** full size used car, six **(5)** ¾ ton pickups with utility beds; and five **(5)** Police Interceptors. State bid prices were available November, 2005 and were compared to bid prices received December 8, 2005.
